Request: A request to repair an existing 36-inch corrugated metal drain pipe by installing a 24-inch drainage conduit sleeve inside and to reconstruct 75 linear feet of deteriorated drain pipe with a new 24-inch pipe connecting existing drainage conduits within an existing drainage easement in the Capistrano Bay Community Services District.
