Brad Fowler (Director of Public Works) responded to questions regarding the estimated timeline for each phase. He noted integrating each phase with South Coast Water District (SCWD) working on their portion of the streets. He also responded to a question about working in sections to keep street lanes open at all times to reduce impacts. He further responded to a question about funding and discussed cost effective measures by reducing expenses on consultants and through relying on existing developers, existing funds, and City staff.

Chairman Denton opened the discussion:

Dana Yarger – (Dana Point) commented that he recently opened an art gallery on Del Prado, and is expanding art and culture related items. He commended staff for the decades of work that has gone into Town Center, and noted that staff has answered his questions this evening. He noted that his business would be in a construction zone, and he suggested flexibility toward temporary signage

permit requirements for small business owners once development moves forward.

Ray Nona (Capistrano Beach) noted that he has lived in Capistrano Beach since 1973. He asked staff for confirmation regarding the articulation of buildings in the Town Center, if there was an architectural style established.

John Tilton (Acting Director) responded that no architectural style is mandated in the Town Center Plan. He confirmed that the Town Center area was no longer covered under the Dana Point Specific Plan, when the building design requirement was in the Cape Code style. There is no specific style, but developers are encouraged to choose a style and building it in a high quality way.

Chairman Denton closed the discussion. He thanked staff for the presentation, and thanked the public for attending.

John Tilton (Acting Director) reported that staff would prepare a Harbor Regulations presentation for a future meeting.
