Name of Project: Headlands Development and Conservation Plan De Minimis Local Coastal Program (LCP)

Amendment - Scenic Drive Vacation and Improvements

Location: The project site is located at the terminus of Scenic Drive and the border of the Headlands

Conservation Park in Dana Point, California

Description of Project: In accordance with Section 30514 (d) of the California Coastal Act, the applicant is requesting a de minimus LCP Amendment with respect to the previously approved vacation of Scenic Drive and related improvements. The proposed Amendment would facilitate the completion of the Scenic Drive vacation process as discussed in the Headlands Development and Conservation Plan (HDCP). The proposed Amendment would vacate the remaining 30-feet of public right-of-way along Scenic Drive as recommended in the HDCP; however, rather than being added to the Headlands Conservation Park, it would be split between the residential enclave (24') and the Headlands Conservation Park (6'). additional 30-feet of public-right-of-way are not needed for the Headlands Conservation Park. Headlands Conservation Park was established previously and satisfies all of its requirements with respect to Environmentally Sensitive Habitat Areas (ESHA) and acreage. All other aspects of the Scenic Drive vacation would be complied with including protection of existing vegetation and necessary removals and replanting. The applicant is also requesting that the approved public view fence that borders Scenic Drive and the Headlands Conservation Park be changed to a solid wall and that Scenic Drive be allowed to be gated. The solid wall and gate is proposed for a number of benefits including reduced fire risk, reduced migration of invasive plant species and/or domestic pets into the Park and further protection of protected species into developed areas, enhanced security and increased opportunities for interpretive signage along the proposed wall for the Headlands Conservation Park.
