#### A. APPROVAL OF MINUTES

#### C. **CONSENT CALENDAR**

There were no items on the Consent Calendar.

#### D. **PUBLIC HEARINGS**

Coastal Development Permit CDP13-0007 and Variance V13-0002 to ITEM 2: allow for a remodel and addition to the existing single-family dwelling at 20 Monarch Bay in the Residential Single-Family (RSF 4) Zoning District. The proposed addition to the existing dwelling will consist of approximately 246 square feet. The existing non-conforming garage, which encroaches into the front setback, will be demolished and rebuilt with an addition of approximately 59.6 square feet. Additional square footage will be added below the new garage in a subterranean level.

Applicant:

Property Owner: Bob Kennedy/Goode Company

Location:

20 Monarch Bay

Request: A Coastal Development Permit and Variance to allow for a remodel and addition to the existing single-family dwelling. The proposed addition to the existing dwelling will consist of approximately 246 square feet. The existing nonconforming garage, which encroaches into the front setback, will be demolished a rebuilt with an addition of approximately 59.6 square feet.

Environmental: The proposed project qualifies per Class 1 Section 15301(e)(1) Categorical Exemption pursuant to the applicable provisions of the California Environmental Quality Act (CEQA) in that the project will result in additions to existing structures that will not result in an increase of more than 2,500 square feet. Additionally, the project is not located in an environmentally sensitive area.

Recommendation: That the Planning Commission adopt the attached Resolution approving Coastal Development Permit CDP13-0007 and Variance V13-0002.

Erica Demkowicz (Senior Planner) provided the reading of the Staff Report to the Commission. She indicated that one letter of correspondence was received for the record in support of the project.

#### Chairman Newkirk opened the Public Hearing.

**William Behun** (Architect - San Diego) spoke relative to the expansion of the existing garage with subterranean level below. He added that the garage expansion will fit within the existing eave-line of the single family dwelling.

### Chairman Newkirk closed the Public Hearing.

Commissioner Whittaker noted that if a non-conforming use is removed, it should be made to conform to the current Code. She stated that the fifteen foot parking area creates crowding towards the street. She stated that she would consider limiting the parking in the driveway to help with the fact that the garage encroaches into the setback.

Commissioner Denton noted that the look and feel will not change on the existing dwelling. He stated that he had no issue given that many of the properties in Monarch Bay have variances for setbacks, and the one additional foot of encroachment would not make an impact. He stated that he would be in favor of allowing the variance.

Commissioner O'Connor stated that this property is not located in the "mall" which pertains to a different set of setback rules. She felt that this proposal is different and that Staff has provided an explanation for granting the variance. She stated that she would be in favor because it is going to be an improvement.

**Vice-Chairwoman Claus** stated that she is not a fan of variances. She stated that there are a number of variances issued by County and they were not consistent. She noted that she would be supportive of the project.

Chairman Newkirk stated that he is not a fan of variances. He felt that each property is reviewed on a case-by-case basis, and in light of the proposed improvements, it is a workable solution to providing parking on the site. He stated that he is in support of the project.

Commissioner O'Connor added that variances should be on a case-by-case basis, and the City needs to be consistent with respect to this subdivision.

Motion carried 5-0. (AYES: Claus, Denton, Newkirk, O'Connor, Whittaker NOES: None ABSENT: None ABSTAIN: None)

### E. <u>NEW BUSINESS</u>

There were no New Business items.

#### F. STAFF REPORTS

**Ursula Luna-Reynosa** (Director of Community Development) noted that the City will be preparing "action minutes" for future meetings. She clarified that taped recordings will be archived for five years for public record and is available to citizens, Planning Commissioners, and Council members.

**Commissioner O'Connor** expressed concern about doing "action minutes". She wanted the record to reflect that she was opposed to the change.

**Jennifer Farrell** (Deputy City Attorney) noted that, if any legal challenges developed, the minutes are only used as a quick resource. If necessary, the audio tape could be transcribed from start to finish.

Chairman Newkirk stated that he would like to have public access to the audio available on-line. He stated that with everyone's busy schedules, it would seem doubtful that the Council members would have time to listen to each audio recording.

**Vice-Chairwoman Claus** stated that she agrees with her fellow Commissioner's and agrees that the minutes often tell the story that resulted in a certain motion. She felt that the "action minutes" would not reflect this.

**Ursula Luna-Reynosa** (Director of Community Development) stated that she would bring back several options to consider.
