<u>Request:</u> Request for a General Plan Consistency determination, GPC13-0003 for the City's vacation of two easements generally located along the south and south easterly property lines of 34215 Pacific Coast Highway.

<u>Environmental:</u> The proposed project is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Section 15305, Class 5 – Minor Alterations in Land Use Limitations in that the project involves the vacation of two City easements that will not result in any changes in land use or density.
