### D. PUBLIC HEARINGS

ITEM 2: General Plan Consistency GPC13-0003, for the vacation of two easements, located along the south and south easterly property lines of 34215 Pacific Coast Highway.

The easements are located to the north of Del Prado, south of Pacific Coast Highway, along the south and south easterly

property lines of 34215 Pacific Coast Highway.

<u>Request:</u> Request for a General Plan Consistency determination, GPC13-0003 for the City's vacation of two easements generally located along the south and south easterly property lines of 34215 Pacific Coast Highway.

<u>Environmental:</u> The proposed project is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Section 15305, Class 5 – Minor Alterations in Land Use Limitations in that the project involves the vacation of two City easements that will not result in any changes in land use or density.

<u>Recommendation</u>: That the Planning Commission adopt the attached Draft Resolution (Attachment 1) finding that the vacation of two City easements located along the south and south easterly property lines of 34215 Pacific Coast Highway are consistent with the Dana Point General Plan.

**Erica Demkowicz** (Senior Planner) summarized the staff report, referring to the information contained therein, gave a PowerPoint presentation, and answered questions from the Planning Commission.

Following a lengthy discussion regarding the ingress and egress for the property without the easement and (future one-way, two-way) traffic circulation on Pacific Coast Highway, Commissioner Whittaker asked for clarification on whether the parcel would be accessible, and requested information regarding the alley and access from it.

**Jennifer Farrell** (Deputy City Attorney) clarified that the issue is whether or not the vacation is consistent with the General Plan. The City Council will make the ultimate determination as to whether or not to actually vacate the easement.

**John Tilton** (City Architect/Planning Manager) added that whether or not the easement is present, the action taken this evening will have no effect on the ability of the property to provide itself access. Removal of the easement would not prevent the owner from having a driveway in the future.

**Ursula Luna-Reynosa** (Director of Community Development) noted that Staff would be happy to address more specific questions related to this matter, but would need the assistance of the Traffic Engineer.

Commissioner Whittaker clarified that she understands that the adjacent alley no longer exists and it is not going to be an opportunity for this parcel.

There being no requests to speak on this item, Chairman Newkirk opened and closed the Public Hearing.

Commissioner O'Connor stated that the easement is not a driveway, vehicular, or property access, and that the ownership or legal rights' has nothing to do with vehicular access in the future. She felt that she can find that this fits with the General Plan and is in favor to vacate the easement.

**Vice-Chairwoman Claus** stated that the proposal tonight is consistent with the General Plan and felt comfortable with the project.

**Commissioner Denton** stated that he agrees with his fellow Commissioners and believes the project is consistent.

Chairman Newkirk also stated that he is in agreement with the other fellow Commissioners who spoke.
