ITEM 2: Art on Display

There was no staff report.

Chairwoman Jenkins gave a brief summary about the various criteria sheets that were a part of the Commissioners packets.

Commissioner Schnell describes their recommendations for criteria for the artwork in the City Council Foyer. These recommendations include Southern California artist, can represent two or three dimensional original art, preferences for imagery relating to the City of Dana Point but not the sole criteria. The subcommittee is looking for a featured artist for a 3 month time period.

Vice-Chair Nowland states that the artists that are not selected are able to apply again.

Commissioner Schnell states that the exhibit would probably begin in September and also that the focus of the subcommittee would be to choose the featured artist for September.

Chairwoman Jenkins suggests possibly using the artwork in the foyer as a place to display some artwork from the elephant parade.

Commissioner Wickstrom states that the artwork relating to the City of Dana Point should be up to the artist because there are so many ways an artist can view and depict Dana Point.

ITEM 3: Future Sites of Public Art

There was no staff report.

Chairwoman Jenkins gave a brief summary on choosing various sites for Public Art.

Commissioner Miller presented his top choices for potential sites for Public Art which included the bridges in Monarch Beach and Capistrano Beach, murals in the empty lots throughout Town Center. He also suggests looking into the signage codes for the various Fast Food signs. He states such codes as lights not being illuminated and the signs have to be a certain size.

Vice-Chair Nowland presented her top choices for potential sites for Public Art which included various sites throughout Lantern Bay Park. She states that she believes that something that can be built upon and include several pieces would be a good idea.

Commissioner Wickstrom suggests utility box artwork which should be a low-cost project. He also states that Lantern Bay Park seems to be a common choice. He states that he likes the idea of a sculpture garden and putting mosaic tiles on the stairs.

Chairwoman Jenkins asks if the ideas should be prioritized or listed in some way.

Vice-Chair Nowland suggests discussing the feasibility of each project and organizing them in that way.

Commissioner Wickstrom suggests finding out costs of the various projects so that the Council could peruse projects as they want to.

Commissioner Miller states that he would like to get more things accomplished before the next Commission takes a hold. He states he would like to have a list of the top 5 choices. He states that his first priority would be the Capistrano Beach Bridge and to remove the fencing and possibly painting and stenciling. He stated that his second priority would be the stairs at Lantern Bay and see if the Harbor would participate in that. He also suggested that we then present that to Council.

Chairwoman Jenkins states that it seems like prioritizing seems to be a popular idea if that is what the Commission should do.

Vice-Chair Nowland suggests grouping the types of projects by bridges, parks, etc.

The Commission agreed upon the following categories: Bridges, Public Canvases, Parks and Specific Sites. The Bridges category includes the Capistrano Beach Bridge. The Public Canvases category includes utility boxes and walls. The Parks category includes the steps at Lantern Bay Park, the sculpture garden at Lantern Bay Park, the bandstand area at La Plaza and the Heritage Park terraces. The Specific Sites category includes the sculpture at City Hall and parking structure in Town Center. The Commission also agreed that the order of priority for the projects should be Lantern Bay Park steps, La Plaza Park bandstand, Sculpture garden at Lantern Bay Park and then the Heritage Park terraces.

Commissioner Miller asks staff for cost estimates of bridge retrofits.

Kevin Evans (Director) states that it is possible to have some of the smaller projects come out of the Parks budget and that the bigger projects would have to wait for money to become available.

ITEM 4: Summer Concert Events

There was no staff report.

Chairwoman Jenkins gave a brief summary and stated that she researched the Summer Concerts for Boston, Pike's Peak Park and Breckenridge. She states that for all three areas they state that they include diverse programming. For example Boston didn't just advertise for Boston they also advertised for Cape Cod, etc. She also states that these areas have diverse locations for performances and that sponsorships are small and not large corporations. She states that Breckenridge allows people to donate and sponsor concerts and events and that people can host events in their homes.

Commissioner Miller states that he researched several large cities including Lake Oswego, Oregon. He states that he would like to do further research. He also states that in order to make Dana Point the City of music that he wants he believes a mission statement would be necessary.
