<u>Environmental</u>: In accordance with CEQA, a Negative Declaration was prepared as required for adoption of the Housing Element. The Annual Housing Element Progress Report does not require further CEQA action.

Recommendation: That the Planning Commission review the 2013 Annual Housing Element Progress Report and receive and file the report.

**Christy Teague** (Economic Development Manager) presented the report and answered questions of the Commission.

**Commissioner Whittaker** asked to encourage the City Council to consider California housing rehab programs for lower income households to help maintain neighborhoods from deteriorating.

**Vice-Chairwoman Claus** asked if motorhomes have been considered on the list of affordable housing. Ms. Teague responded that they are not and clarified that they are listed under the homeless count and aren't considered as dwelling units.

**Commissioner Denton** asked if the area around the Town Center Post office falls under the moderate priced homes or a different category. Ms. Luna-Reynosa responded that it is possible but not mandated.

**Chairman Newkirk** asked if income levels are defined in these categories. Ms. Teague responded that they are, with a slight increase of qualifying incomes, and these percentages are indexed annually.

Chairman Newkirk declared that the Planning Commission has Received and Filed the 2013 Annual Housing Element Progress Report as required by State law.
