A. <u>APPROVAL OF MINUTES</u>

ITEM 2: Dana Point Plein Air Competition

Chairwoman Nowland introduced Commissioner Schnell to give information.

Commissioner Schnell described the Plein Air competitions that are happening locally, including San Clemente and Laguna Beach and gave descriptions on the specifics of these competitions. She explained what bringing a Plein Air competition to the City of Dana Point would entail, including prize money and sponsorships. She states that the time of the competition would depend upon when other competitions are being held. She states that working in collaboration with non-profits would be beneficial.

Vice-Chair Schmitz stated that she believed that this would be a good collaboration with existing non-profits who could take ownership of the event.

Commissioner Jenkins asked if a twist on the competition would be possible to expand the competition such as potentially placing artwork in local businesses.

Kevin Evans (Director) states that there is potential to add this element to various City events which could include the Concerts and the various Festivals that the City holds.

Vice-Chair Schmitz states that it is very important to give a specific roles to the non-profits so that they know that the City and the Commission supports them.

E. OLD BUSINESS

ITEM 3: Art Quest

Chairwoman Nowland gave a brief summary of Art Quest and stated that she has contacted the School of the Arts at Dana High School and they are excited to provide art and stated that she is currently trying to contact the Chamber of Commerce.

ITEM 4: Public Art on Display

Chairwoman Nowland introduced Commissioner Raub.

Commissioner Raub gave a summary of the artwork displayed at the City Council Chamber Foyer and stated that the display will be quarterly.

Commissioner Raub also stated that the artwork displayed at the Community Center will also be run on a quarterly schedule and that they will encourage the various schools to display their artwork.

ITEM 5: <u>Elevating Cultural Arts in a Destination City</u>

Chairwoman Nowland introduced Commissioner Jenkins.

Commissioner Jenkins stated that she shared her research at the previous meeting and states that Commissioner Schnell will also be sharing her research. She also stated that she was hoping to meld all of the research into one format.

Chairwoman Nowland stated that she also came up with some ideas and they included researching goals of other Arts and Culture Commissions, identify art assets that differentiate Dana Point from other cities, how to increase dedicated space for arts and cultural events and to create criteria for arts donations.

Vice-Chair Schmitz stated that she would like to research dedicated space for arts and cultural events.

Chairwoman Nowland states that she would like to research other Arts and Culture Commissions. She states that creating the criteria for art donations would be another good place to start.

F. STAFF REPORTS

Kevin Evans (Director) gave a staff report and stated the Elephant Parade was doing well in Dana Point and that the seniors are being taken on a special trip throughout the city to see the various elephants. He also stated that the public art piece in Lantern Bay Park is up but that the landscaping is not finished and once it is there will be a soft opening.
