SUBJECT: A STUDY SESSION FOR COASTAL DEVELOPMENT PERMIT CDP04-11, SITE DEVELOPMENT PERMIT SDP04-31 AND CONDITIONAL USE PERMIT CUP04-21 FOR THE PROPOSED DEMOLITION OF THREE EXISTING BUILDINGS AND CONSTRUCTION OF FOUR NEW BUILDING AND A TWO LEVEL, SUBTERRANEAN PARKING STRUCTURE ON A 6-ACRE SITE AT SOUTH SHORES CHURCH.

LOCATED AT 32712 CROWN VALLEY PARKWAY.

NOTICE:

Notice of availability of the draft EIR for the proposed project and today's study session was mailed out to property owners within a 500-foot radius, occupants within a 100-foot radius select communities of Ritz Pointe residential neighborhood on September 15, 2014. The study session notification was also posted on the City's web site and social media sites.

**ENVIRONMENTAL:** 

Pursuant to the California Environmental Quality Act (CEQA), a draft Environmental Impact Report (dEIR) is prepared for the proposed project by the City and the City's environmental consultant. LSA Associates. The dEIR was released for public comment on September 15, 2014. The 45 days public comment period will end on October 30, 2014. The City and LSA Associates will then prepare responses to comments and a final EIR for the proposed project.

#### BACKGROUND / DISCUSSION:

The proposed project was initially submitted to the City in 2004. A Mitigated Negative Declaration (MND) was prepared for the proposed project at that time. Two public hearings were conducted by the Planning Commission on June 15, 2009, and then on July 20, 2009 to consider the MND and the propped project. After receiving extensive public testimony at those hearings, the project was tabled.

The process to prepare an EIR for the project before bringing it back to the Commission was then initiated by the City. The project since then has been re-designed to address geo-technical concerns and a "Reduced Alternative Design" has been proposed by the applicant. The dEIR analyzes the prior "Lead Project" but also details the "reduced alternative design".

Staff is recommending that the Commission receive the presentation from the applicant, conduct a study session, and provide comments and direction to the applicant as appropriate.

I have been resident homeowner of Dana Point for over 30 years and a member of South Shores Church for over 15 years. I have seen many changes in our City over those years, most of which have been a benefit to the quality of life for those living or visiting our City. I want to thank each of you on the current Planning Commission for your continued efforts to further improve and upgrade our fine City.

The alternative Master Plan being submitted by South Shores Church is clearly a project that will enhance our community. This project has amenities that will benefit the entire area. These benefits include the removal of old, termite infested buildings, the erection of a new Community Life Center with a gymnasium, architectural consistency on the campus, more parking underground, special rainwater treatment capabilities added, and a scenic garden view point. The Church grounds will be open to the public and parking is free. The Church has made many compromises to insure that view corridors are optimized. In fact, the new buildings roof elevations are not as high as the old ones, and trees will be trimmed down to increase our neighbor's views. The total campus building square footage has been reduced to about 71,000 from over 89,000.

It is my understanding that the Church has done an extraordinary amount of work, over an extended period of time, to study the impacts of the project and listen to their neighbors. The City staff has also been very diligent in its efforts to have the project comply with all of the various rules, regulations and concerns of the residents of the City. It is also my understanding that no variances to any regulations are required by the alternative Master Plan and that there are no significant impacts reported in the DEIR. I believe these facts make your decision to approve an easy one.

It is now time to build. Personally, I cannot see what possible rationale basis exists for not approving the alternative Master Plan for South Shores Church. I strongly urge your approval and support without any further delay.

Although our home has won awards from community organizations, it could not be rebuilt under the current codes. We have lived in Dana Point since 1988 and have attended South Shores since 1999. South Shores is a great asset to our community; it provides meeting space for many non-church organizations. The goal of the building project is to provide the community with better facilities for meetings and activities; especially youth focused activity space which is lacking in our City.

I have read the editorial penned by Todd V. Glen opposing the South Shores Master Plan and believe it distorts the truth of project impacts. It is sad when groups gloat over an ability to prevent property owners from using their property is a way that complies with the Dana Point General Plan. The South Shores site is designated for a community facility and the increase in population of the local community necessitates an increase in the size of the Church facilities. The Church has been in operation much longer that most of the neighboring homes have been in existence. I believe that their complaints about over expansion are without merit and disingenuous.

South Shores Church members are from all over Southern Orange County and their attendance benefits the local businesses. Many members enjoy eating at our local restaurants after services and events. The Church is supportive of the community and the community should not interfere with the Church. I realize that there are some people who will oppose all changes and create delay and extra costs to the projects.
