Applicant: Terry and Patricia Liebman

Location: 33801 Cabrillo Isle (APN 672-071-20)

<u>Recommendation:</u> That the Planning Commission adopt the attached resolution approving Coastal Development Permit CDP15-0010.

<u>Environmental</u>: Pursuant to the California Environmental Quality Act (CEQA), the project is Categorically Exempt per Section 15301 (e) (Class 1 – Existing Facilities) in that it proposes a nominal increase in square footage to an existing residential dwelling.

Request: Approval of a Coastal Development Permit to allow the addition of 659 square feet of floor area, 324 square feet of expanded garage area and a 196 square foot basement at an existing 4,580 square foot single-family dwelling located at 33801 Cabrillo Isle on land located within the City's Coastal Overlay District (the California Coastal Zone) and the Appeals Jurisdiction of the California Coastal Commission.
