Explained how they have contacted the Secretary of State to begin the process of Articles of Incorporation and IRS to apply as a non-profit organization. Stated how they have commitments of pledging for funding and how they will be seeking a private-public combination for funding. They will begin that week to fabricate some of the memorial and would like to have it completed within one year. Confirmed the labor cost is included in the total cost of \$334,000. Stated they will follow up with photos of the memorial's progress. He also stated they met
