**Amendment to Coastal Development Permit CDP15-0021:** A Coastal Development Permit concerning the regulation of hours of operation of Strand Access areas, including Strand Vista Park and the beach access ways, located at the Dana Point Headlands, modification of provisions regarding gates at the Mid-Strand Beach Access and Central Strand Beach Access, and introduction of an ordinance amending Chapter 13.04, Parks and Recreational Facilities Regulations, of the Municipal Code to reflect modified hours of use in the Strand Access areas.

In any such action or proceeding seeking judicial review of, which attacks or seeks to set aside, or void any decision of the Dana Point City Council, shall be limited to those issues raised at the hearing as provided in Chapter 2.50 of the Dana Point Municipal Code.
