He proposed a Dana Point Gaming and Music Festival which would offer character-based college scholarships to children in Dana Point. He proposed a date in October when many of the large game corporations would be in the area for a game festival. He stated that 100% of the proceeds would go to the community, to families who are suffering, and for scholarships.

City Manager Chotkevys replied that the appropriate process would be for Kevin Evans to agendize this proposal on the next Arts and Culture agenda, receive a recommendation, and then it could be discussed at a future City Council meeting.
