PUBLIC COMMENTS

Pamela Schuler, Dana Point, spoke regarding the Pet Project Foundation and stated that they were always looking for more volunteers. She reported that a fundraising luncheon was going to being held on Saturday, June 4 at 11:30 a.m. for \$60 per person at L'Hirondelle which will help offset the animals' medical costs.

Cindy Monroe, Dana Point, spoke regarding the impact that the ballot measures have had on businesses with Measure H supporters boycotting the businesses supporting Measure I. She urged the City Council to continue moving forward the progress that has been made in the Lantern District.

Cyndi Elders, Dana Point, spoke regarding the ballot measures. She stated that she was upset about the way the businesses were being treated. She felt that the

measures were very confusing to the public and thanked the Council for bringing forward Measure I.

Gary Macrides, Dana Point, representing Dana Point Chamber of Commerce, spoke of the division in the community that have been brought on by the competing measures. He stated that some of the tactics have been mean-spirited and ugly. He added that now proponents of Measure H are threatening the businesses with boycotts. He stated that the Chamber would like to remind the community that these businesses are the same ones who have supported the community's youth sports, service clubs, schools and non-profits for years.

Enzo Scognamiglio, Laguna Hills, thanked the City Council for all the work that has been done in the Town Center. He spoke of the way supporters of Measure H have been acting in the community against anyone who does not share their view.

Joanie McKnight, Dana Point, stated that she was not necessarily opposed to short term rentals, but that she would like a 30 day minimum stay similar to what the City of Laguna Beach enforces.

Shelley Furse, Dana Point, stated that vacation rentals has changed her neighborhood from a close knit community to now being a much more transient street. She added that she would support a 30 day minimum stay.

Desiree Goerriere, Dana Point, stated that there were ten short term rentals within 25 feet of her home. She felt that they were a security threat for the residents. She added that short term rentals were driving up the rental costs of homes and that she would support a 30 day minimum stay.

George Ray, Capistrano Beach, stated that he operates two short term rentals and reported that they have not had any problems with their rentals.

Mayor Tomlinson closed the public hearing.

Council Member Schoeffel spoke about the many views that were represented over the years when drafting the Ordinance. He felt that the Ordinance struck the best balance and that the amount of complaints has been very small since the Ordinance was adopted. He stated that he would make a motion to approve the recommended action.

Council Member Olvera stated that he had voted against establishing vacation rentals but felt that this was a very good model that was working and that he would second the motion.

PUBLIC COMMENTS

Carol Kelly, Dana Point, stated that she supported Measure H because she felt that the City did not follow the rules and regulations. She added that they allowed extreme changes to parking and building heights. She felt that increased density and fewer parking spaces would not serve the Town Center well.

Bob Theel, Dana Point, stated that he voted no on Measure H and yes on I. He added that the private parking spaces being converted to public parking will prevent the spillover into the residential area. He stated that people are confused about the Measures because the signature gatherers confused them. He felt that the Town Center plan, parking plan and Measure I was the only way Town Center would be successful.

Juinton Lin, Capistrano Beach, stated that two of her children were in the Mandarin immersion program in Laguna Niguel and asked the City Council to adopt a Resolution for a fair location of the Mandarin immersion program to be located. She felt that Measure I would provide an opportunity to create a vibrant community that Dana Point deserves.

Justin Basie, Dana Point, stated that he was unhappy with the vacant lots in the Lantern District. He felt that Dana Point has a bright future and hopes that Measure I passes. He added that the residents need to trust the Council to hire competent individuals to create the parking plans and development plans that would help the City to grow. He stated that Measure H would take the power away from the officials and put it with people who might not know how things should be executed in a long term approach.

Franco Arena, Dana Point, felt that Dana Point has gone in a great direction and that support of Measure I will actualize the vision of the Town Center.

Jason Check, Carlsbad (Raintree Partners managing director for development) stated that he was excited about what was happening in the Lantern District and for bringing to the City a great project. He added that the approval of one project or a few projects does not ensure the success of the district nor does the approval of a single project

define the character when it is completed. He stated that the desired outcome of their project is to be a part of the Lantern District neighborhood and that they aspire to be embraced by the community.

Cindy Fleming, Dana Point, reported that shared parking in the lantern business district happens organically and has rarely been a problem because the mix of uses offset the peak hours of parking need for the others. She felt that shared parking throughout the Lantern District would not work because the City Council is reducing the parking ratios.

Betty Hill, Capistrano Beach, spoke of the differences between Measure H and Measure I

George Ray, Capistrano Beach, spoke of the project that has been approved on PCH and Golden Lantern under the old Ordinance. He stated that if that project does get built there will be the expense of three levels of underground parking. He felt that the City Council has made a prudent statement by altering the parking that will help create a vibrant downtown with residential development which is needed.

Patti Short, Dana Point, stated that she supports Measure I. She felt that Measure H would stop the progress in the Town Center because it would change the previously approved Town Center Plan and if passed would require returning to the Coastal Commission. She added that Measure H would establish ballot box zoning, eliminates the City's ability to grant Variances and Conditional Use Permits, requires any deviation of the Plan to be approved by the voters which would result in delays and additional costs for the public to vote.

STAFF REPORTS

City Manager Chotkevys thanked staff for doing a great job for everything they do in the City and also complimented the Sheriff's Department for their willingness to make this one of safest communities in the state.

Council Member Schoeffel asked the City Manager if he was aware of the County audit of certain activities in the Harbor and asked when there would be a public discussion and review of the audit because he has been receiving questions.

City Manager Chotkevys replied that yes he was aware of the audit. He stated that the public would need to contact the County regarding their audit. He added that there had been an accusation made that a City employee had benefitted from that program; he stated that no employee took part or benefited from that program.

Council Member Schoeffel asked if the public should contact Mr. Wollery's office. City Manager Chotkevys replied yes.

COUNCIL REPORTS, INCLUDING CITY RELATED MEETINGS ATTENDED

Council Member Olvera stated that since he was a mechanical engineer he would like to present a mechanical award called the "Mama Says" award. He reported that the OC Library Board had approved their budget recently and that they use a grading system for every branch library for the allocation of funds received through property taxes and that grading system determines the hours for a facility to be open. He added that Dana Point use qualifies for six days of operation and he wanted to reaffirm that the City of Dana Point supports the library system and pays for the library to be open on Sunday. He stated that a press release was to be issued that the first indication of West Nile Virus has occurred in Seal Beach and La Habra. He added that he supports the CUSD Mandarin immersion program and would like south county children to be able to participate. He stated that he would turn in his list of meetings to the City Clerk.

Council Member Schoeffel thanked Nancy Jenkins, Karin Schnell and everyone at the City who did a great job on the art walk of this past weekend. He reported that Jack had hired musicians to play in front of his restaurant. He stated that he would like to see more events like this.

Council Member Muller stated that the City has a great Fire Authority and recognized Station 29 for a fantastic job in saving a visitor's life in April. He added that he would turn in his list of meetings attended to the City Clerk.

Mayor Pro Tem Viczorek stated that he would turn in his list of meetings to the City Clerk.

Mayor Tomlinson stated that he would turn in his list of meetings to the City Clerk.
