Item 2: Establishment of Residential Preferential Parking District Street Sections in Lantern Village

Fowler opened with a discussion on the findings of a survey that was conducted for the residents of the Lantern Village abutting Blue Lantern, Seville, Ruby Lantern, and Granada between San Marino Place and La Cresta.

There were eight speakers on behalf of this item: Craig Williamson, Donald Shultz, Mary Orr, Eoin O'Cuilleanain, Gary Johnson, Trent Hofferber, Sara Lomonico, and Jane Downs. All speakers were in favor of establishing preferential parking in Lantern Village.

A discussion was held on the issue of whether any permanent guest passes should be issued beyond the two permanent passes, but the recommendation in the Staff Report was not changed for this area.

A resolution was proposed by Cline to establish/designate preferential parking restrictions on Blue Lantern between San Marino Place and 34122 Chula Vista on the west side and 34146 Blue Lantern on the east side; Seconded by Orlando. *Motion passed.* (*Ayes-5; Nos-0*).
