C. CONSENT CALENDAR

Item 2: Approval of Action Minutes from May 18, 2016 Traffic Improvement Subcommittee Meeting

Motion was made by Subcommittee Member Elders to approve the May 18, 2016 Action Minutes; Seconded by Subcommittee Member Orlando. *Motion passed.* (Ayes-4; Absent-1).

D. PUBLIC HEARINGS

Item 3: Consideration of Implementation of Additional Residential Preferential Parking District Street Sections in Lantern Village

Fowler opened with a discussion on the findings of a survey that was conducted for the remainder of residents of the Lantern Village north of the Lantern District to La Cresta Drive including La Serena Drive, Amber Lantern, El Encanto Ave., Violet Lantern, Colegio Drive, Silver Lantern, Malaga Drive, Alcazar Drive, Copper Lantern, and Star Ridge Road.

There were no speakers on behalf of this item.

A motion was made by Subcommittee Member Boughen to uphold the recommendation of City staff to not establish/designate any additional Preferential Parking District restrictions on other streets at this time; Seconded by Howell. *Motion passed. (Ayes-5; Nos-0).*

Item 4: Consideration of Extension of Residential Preferential Parking District on Chula Vista South of Selva

Fowler opened with a discussion on the findings of a survey that was conducted for property owners along Chula Vista from Selva Road further south on each side of the street extending to 33851 and 33852 Chula Vista.

There were seven speakers on behalf of this item: Alana Krunk, Donald Shultz, Gary Johnson, Mark Brunson, Brad Kelly, Cynthia Roberts, and Dr. Mariel Langford; five in favor of Preferential Parking, one against and one asking about a different location.

A discussion was held regarding impact to surrounding streets adjacent to the Preferential Parking District extension area but it was determined that further studies would need to be done to determine the necessity of expanding the boundaries beyond City Staff's current recommendation. Further, notification and owner participation is required from other streets to consider additional Preferential Parking Districts.
