City Attorney Muñoz reported that the City had settled the liability claim. He clarified that the settlement decision was not a Council decision; it was negotiated and arranged by the City's insurance carriers. He stated that the City has a "per occurrence" policy which means that the City would have adequate insurance to cover itself and protect the assets of the community from future incidents. He added that the City joins other Cities and pools its resources and the pool's assets were not in jeopardy in any way.

Business of the Month - St. Regis Monarch Beach Resort and Spa

Management Analyst Kelly provided a PowerPoint presentation. She stated that the St. Regis had recently received a Triple A 5 Diamond Award and a Mobil Travel Guide 5 Star Award making the St. Regis the only resort in California and Arizona to receive both awards. Among other awards they were also named on *Conde Nast's* 50 Top Spas list and Top 100 Golf Courses. Mayor Harkey presented a Certificate of Recognition to the General Manager of the St. Regis Monarch Beach Resort and Spa, Johnny So for being the featured Business of the Month for December.

Deputy of the Year

Chief of Police, Lt. Levy and Captain Ron White introduced Deputy John Good, his wife Allison and daughter Megan. Lt. Levy stated that the Deputy of the Year honor is given to the Deputy who not only responds to particular crises valiantly, but maintains a great attitude while performing mundane tasks with care and professionalism day in and day out. He added that this award is voted on by the Deputy's peers. He added that Deputy Good has been with the Orange County Sheriff's Department for over thirteen years. He has spent six of those years here in Dana Point where currently he is a member of the City's Community Service Unit and the alternate School Resource Officer. Mayor Harkey presented Deputy Good with a Certificate of Recognition and expressed heart felt thanks for his service to the community.

Firefighter of the Year and Reserve Firefighter of the Year

Battalion Chief Steve Whittaker and Division Chief Rick Robinson introduced Jeff Hughes and his daughter Jensen. Battalion Chief Whittaker stated that Jeff was currently serving as a Fire Apparatus Engineer out of Station #59 in San Clemente. He added that Jeff has been a member of the Fire Authority for the past twenty-two years and has made many contributions to the Fire Authority above and beyond his regular duties including making himself an expert at ladder truck operations, co-written an apparatus manual, peer fitness trainer, and had recently successfully competed for the position of Fire Captain and is waiting for the next opportunity for a promotion. Mayor Harkey presented Jeff Hughes with a Certificate of Recognition for his selection as the Career Firefighter of the Year.

Battalion Chief Steve Whittaker and Division Chief Rick Robinson introduced Brodie Lefebvre, his wife Anna, and his children Ada, Brodie Jr., Elka, and Olia. Battalion Chief Whittaker stated that reserve firefighters are members of the community, who volunteer their time, are trained to be a firefighter in addition to maintaining a regular career and family life. Orange County Fire Authority Presentation – Chief Chip Prather

Video footage from the Santiago wild fire was shown. He stated that the CERT Team had provided support at the OCFA base camp and performed many important duties, including serving meals two times a day to two thousand people, keeping track of the firefighter's time worked; they passed out much needed supplies to the firefighters, and basically did whatever was asked of them. He thanked the City Council for their support of the Santiago fire effort and for the contribution that the City's CERT Team had made.


