E. STAFF REPORTS

ITEM 3: WATER QUALITY PROGRAM UPDATES

Ms. Zawaski provided the following updates:

- There was a successful Earth Day Event held at the Nature Interpretive Center on Saturday, April 22, which included a water quality outreach booth.
- The South Orange County Water Quality Improvement Plan (WQIP) is out for public comments through May 8 and the Regional Water Quality Control Board (RWQCB) staff indicated that they will provide comments or acceptance letter by the end of August.
- RWQCB staff has indicted that the City should expect the Investigative Order for the Trash Basin Plan Amendments by the end of June.
- The County, City and Monarch Beach Resort, in cooperation with the Monarch Bay Homeowner's Association, are working out some final details to implement the bird deterrent program at Salt Creek and Monarch Beach that will be implemented by three cost-sharing partners.

ITEM 4: SCHEDULE FIELD TRIPS

The Subcommittee members agreed to include a field trip to the Salt Creek Ozone Treatment Facility at the next meeting and to start the meeting at 2 p.m. instead of 3 p.m. in order to accommodate the tour.

F. SUBCOMMITTEE COMMENTS

Meeting attendee Rick Erkeneff inquired as to why the Salt Creek facility only operates during the summer season. The City indicated that it is a funding issue and the facility was designed to operate consistent with the State AB411 period, where beach usage is highest.
