C. <u>NEW BUSINESS</u>

Item 2: Santa Clara between Ruby Lantern and Old Golden Lantern

Matt Sinacori introduced the item outlining the resident's concerns on Santa Clara between Ruby Lantern and Old Golden Lantern to Subcommittee Members. A Power Point Presentation was prepared and he introduced would partner with Rich Barretto with Linscott, Law and Greenspan, Engineers (LLG) to provide the presentation.

Rich Barretto with Linscott, Law and Greenspan, Engineers (LLG), provided the Subcommittee with an overview of the existing conditions on Santa Clara, a summary of the traffic data collected by LLG, and a summary of the warrants and recommendations for traffic calming measures on Santa Clara.

Mr. Sinacori continued the presentation by outlining the criteria for Dana Point City Council traffic calming policy.

Mr. Barretto discussed all of the striping modification options.

Mr. Sinacori discussed the request for bulb outs at entrance points to the Santa Clara neighborhood as requested by the residents. The residents made this request to try to deter commercial parking spillover into their residential neighborhood. He explained this was an informational item only and that the City Council would need to consider these specific elements if desired due to the cost of the suggested improvements.

Mr. Denny let the Subcommittee and the audience know that there will be a joint meeting with the Planning Commission and City Council to discuss parking issues citywide either on May 8th or May 15th and that City Staff would notify them once the date is set.

There were four speaker on this item: Annie Stoeckmann, Carol Kelly, Cindy Fleming and Tracey Williams. All speakers indicated their support of the City's recommendation of implementing traffic calming measures on Santa Clara.

Motion was made by Subcommittee Member Howell to:

- 1) Adopt the recommendation of the City staff to approve the conceptual striping plan for Santa Clara and direct staff to implement it in the next 90 days, and;
- 2) Direct staff to implement a median island and dead end signage at Ruby Lantern, in conjunction with the striping modifications, to help thru traffic avoid entering this road segment. Seconded by Rosales. *Motion passed. (Ayes-5; Noes-0).*
