### **CALL TO ORDER**

The Regular Meeting of the City Council of the City of Dana Point, California, was called to order by Mayor Rayfield at 5:02 p.m. in the Dana Point City Council Chamber, 33282 Golden Lantern, Suite 210, Dana Point.

### RECONVENE CITY COUNCIL MEETING

Mayor Rayfield reconvened the meeting at 6:01 p.m. All Council Members were present.

### PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was led by Trish Minty of the Mariner Sea Scouts.

#### INVOCATION

The Invocation was led by Pastor Dave Keen of South Shores Church. Pastor Keen spoke of his recent Missionary trip to South Africa.

#### **CLOSED SESSION ANNOUNCEMENT**

City Attorney Muñoz reported a settlement has been reached in the matter of Closed Session Item C, Diedrich Coffee, Inc. v. City of Dana Point, et al, Orange County Superior Court Case No. 05CC03529 which was now in effect. The Court has determined that Deidrich is able to retain the drive-through which had been previously operated at that location, as well as ruling against Deidrich on its damage allegations, determining they were not entitled to sue the City of Dana Point for damages. Deidrich has voluntarily dismissed its allegations against Mr. Chilton and has issued an official statement of regret relating to Mr. Chilton which reads as follows "Deidrich's lawsuit against the City included City Council Member Russell Chilton based on information Deidrich received from third parties. After extensive discovery and thorough investigation, Deidrich has determined that there is insufficient evidence to pursue any litigation against Mr. Chilton personally. Deidrich regrets Mr. Chilton was a necessary party to the litigation." The Deidrich litigation has been successfully concluded, Mr. Chilton has been exonerated, and the City has a written agreement with Deidrich's that they are allowed to operate the drive-through only exactly as it has always been operated, with documentation to verify that. Any changes to the drive-through will require a Conditional Use Permit from the City.

Council Member Chilton stated that "sometimes as an elected official you have to go through a very painful process. Being named in this litigation was not pleasant for my family or myself, but you only need to look as far as the third parties referred to in the litigation brought forward by Mr. Bill Ossenmacher and Greg Powers. Throughout the course of this litigation when people came up and asked me what was going on, I only got so far as to say 'Bill Ossenmacher' and eyes would roll and they'd shake their head and that would be the end of it. It's an unfortunate situation, but nonetheless it's unfortunate that Dietrich's was introduced to this community by Bill Ossenmacher, because had that not happened I think their experience would have been a lot different. Having said that, we need to move on, we need to welcome Dietrich's into our community and put this thing to bed."

Mayor Rayfield stated "not only was Councilman Chilton wrongly accused in this suit, but so was the City of Dana Point. I am delighted that Councilman Chilton was exonerated and I feel that the City and the City staff have also been exonerated. We are glad to have that behind us and go forward."

#### STAFF REPORTS

There were no staff reports.

#### **COUNCIL REPORTS**

Council Member Chilton reported he, Mayor Rayfield and Mayor Pro Tem Anderson had attended the Boys and Girls Club of Capistrano Valley annual gala event on Saturday, September 10<sup>th</sup>, an event which had received tremendous support.

Council Member Chilton noted the next Traffic Improvement Subcommittee meeting would be held on Wednesday, September 21<sup>st</sup> at City Hall, where the issue of street sweeping would be discussed. Citizen participation in that discussion was highly encouraged.

Council Member Lacy reported on his attendance at the art walk held at Cliff Wassmann's gallery on the first Friday of the month. The event was well attended and beautiful art had been displayed.

Council Member Lacy reported on yesterday's meeting of the Ocean Water Quality Subcommittee, where progress is being made regarding an incentive program for restaurants involving grease traps.

Council Member Lacy noted that the appointment of Congressman Chris Cox as Chairman of the Securities and Exchange Commission has resulted in the City of Dana Point being without a Congress Member for the next few months due to the pending special election. This could potentially affect our City's ability to obtain federal support for cleanup of the harbor and a defining benchmark study of the sources of pollution at Doheny State Beach. An active effort to gain assistance with these issues from other Congress Members in areas close to Dana Point is being conducted.

Council Member Lacy reported that on August 30<sup>th</sup> he and his wife had celebrated their eighteenth wedding anniversary by renewing their vows at St. Edwards Church.

Council Member Harkey reminded everyone of the upcoming Dana Point/Capistrano Beach Historical Society Home Tour on October 2<sup>nd</sup> from 11 a.m. to 4 p.m. and noted her home would be included in the tour.

Council Member Harkey stated she would be hosting an event for State Senator John Campbell, who is running for Congressman Cox's vacated seat, on September 24<sup>th</sup> from 4 p.m. to 6 p.m. at her home and invited everyone to attend.

Council Member Harkey reported on her attendance at a Library Advisory Board meeting on behalf of Council Member Chilton, who was unable to attend. Under the County of Orange's new allocation of funds, Dana Point would receive the same amount as last year, rather than a reduced amount as was previously planned.

Council Member Harkey stated Assemblywoman Mimi Walters will conduct a session on illegal immigration at the Laguna Hills Community Center on Thursday, September  $22^{nd}$  from 6-8 p.m.

Council Member Harkey requested a study session be conducted to review the recommended revisions to City Council policies by Mayor Pro Tem Anderson and Council Member Lacy prior to them being submitted for approval at a regular City Council meeting.

Council Member Harkey spoke regarding the letter submitted at this meeting by Lisa Bartlett of C.A.R.E. Dana Point and in favor of submitting the Town Center Specific Plan to the voters in 2006.

Mayor Pro Tem Anderson spoke regarding financial discussions held by the Foothill/Eastern Transportation Corridor Agency and the San Joaquin Hills Transportation Corridor Agency. The San Joaquin Hills Transportation Corridor is in danger of going into default in 2007. The Boards have been attempting to come up with a proposal whereby the Foothill/Eastern TCA would make payments to the San Joaquin Hills TCA to mitigate future impacts from the proposed extension of the Foothill Corridor Road, which is the Foothill South, as well as allowing the San Joaquin Hills TCA to take out loans against the Foothill Eastern TCA.

Mayor Pro Tem Anderson reported on the Dog Fun Zones in selected Dana Point parks. The fenced dog runs have been installed on a trial basis.

Mayor Pro Tem Anderson stated that October is National Breast Cancer Awareness Month and also noted that heart disease kills more women than the next six largest causes of death combined.

Mayor Pro Tem Anderson reported the Utility Undergrounding Subcommittee had a productive meeting last week and was working as quickly as possible on the issue of undergrounding utilities in Dana Point neighborhoods.

Mayor Pro Tem Anderson reminded everyone of the Town Center Subcommittee meeting to be held tomorrow, September 15<sup>th</sup>.

Mayor Rayfield spoke of the West Nile Virus, a serious threat to our country, and the need to get rid of standing water around properties.

Mayor Rayfield stated the harbor revitalization project's Environmental Impact Report will be published by September 27<sup>th</sup> for public review and comment during a 45 day comment period.

Mayor Rayfield spoke regarding breast cancer survivor Kim Tilley of the Harbor Association. On Sunday, September 25<sup>th</sup>, Dana Wharf Sportsfishing is sponsoring a twilight cruise in the harbor with the proceeds going to fight breast cancer.

Mayor Rayfield stated Saturday, September 17<sup>th</sup> is National Beach Clean Up Day. Doheny State Beach will be cleaned from 8 – 11 a.m. and Salt Creek Beach will be cleaned from 9 a.m. – 12 p.m. Volunteers need only to show up on Saturday to help out.

Mayor Rayfield noted that Friday, September 16<sup>th</sup> would be an observance of POW/MIA's as well as Developmental Disabilities Day.

Mayor Rayfield reported that flu shots for seniors would be available October  $22^{nd}$  at the Dana Point Community Center.

Mayor Rayfield reported the Town Center Subcommittee regular meeting will be held tomorrow evening at 6:00 p.m., where the primary topic for discussion will be building heights. Friday, September 16<sup>th</sup> at 8 a.m. a special briefing will be held primarily for business owners and business property owners to inform them of the subcommittee accomplishments to date and the future topics to be addressed.

Mayor Rayfield provided a status report on the pilot circulation program to move the water around at Baby Beach, which is cause for optimism as circulation has long been suspected as a critical factor in the postings at the beach.

Mayor Rayfield stated the Salt Creek Treatment Facility will go into use in order to finetune the operation before actually activating. A ribbon cutting ceremony will be held mid-October.

There being no further business before the City Council at this session, Mayor Rayfield declared the meeting adjourned at 8:36 p.m.
