City Manager Chotkevys made no report.

City Attorney Muñoz reported that as a board member of the Raise Foundation, a child abuse prevention organization, he would be distributing Blue Ribbon pins to the City Council to wear in recognition of Child Abuse Prevention Month/Blue Ribbon Month during the month of April. Mr. Muñoz also noted the Foundation had awarded Dana Point resident Pam Alexander their annual Blue Ribbon Award, given to an individual demonstrating a passion towards child abuse prevention in the County of Orange.

COUNCIL REPORTS

Council Member Chilton commented on the excellent discussion regarding the Planning Commission at tonight's meeting.

Council Member Chilton encouraged members of the public to contact him with any concerns they may have.

Council Member Harkey reported she had toured two recycling plants and commented on the manual labor required to sort through recyclable items.

Council Member Harkey noted she would like the City Council to recognize Pam Alexander, recipient of the Raise Foundation Blue Ribbon Award.

Council Member Harkey spoke of the role of the City Manager and City Attorney with regard to the City Council. The City Manager and City Attorney had supported the former Council and were now supporting the current Council to the best of their ability.

Council Member Lacy noted he would like the City Council to recognize Pam Alexander, recipient of the Raise Foundation Blue Ribbon Award.

Council Member Lacy encouraged the public to communicate their concerns with City Council Members and promoted use of his blog site (www.workingfordanapoint.com/blog) to communicate with him.

Council Member Lacy noted that the Planning Commission does a fine job and that he was pleased to have appointed the best people to the Commission this evening.

Council Member Lacy reported on his attendance at the Transportation Corridors Agency (TCA) as an alternate to Mayor Pro Tem Anderson, who was on vacation. Mr. Lacy commented on the fossil collection that the TCA has collected from corridor construction sites and noted the Ocean Institute would be a good place for students to view these fossil bones.

Council Member Lacy requested agendizing discussion of increasing the public nuisance fines and increasing the fee for filing an appeal of Planning Commission decisions to the City Council on the April 27, 2005, City Council agenda.

Mayor Pro Tem Anderson reported on the Native Habitat Tour Series offered every spring by the TCA, hiking through the 2,100 acres of open space protected as part of the construction of the 241 and 73 toll roads. Tours are held on Saturdays beginning April 23rd. Flyers will be available at City Hall or on the TCA website.

Mayor Pro Tem Anderson reported on her attendance at the March 31st Healthy Transportation Network Dinner, where ways to design neighborhoods and cities as more friendly for walking and biking activities were discussed.

Mayor Pro Tem Anderson stated the Utility Undergrounding Subcommittee was moving forward and applications for citizen representation appointment to the subcommittee will be available on the City's website tomorrow.

Mayor Pro Tem Anderson noted the San Clemente/Dana Point Animal Shelter needs foster families for kittens too young to stay at the shelter and encouraged those interested to contact the shelter.

Mayor Rayfield reminded everyone of the three subcommittees approved at tonight's meeting, each of which will have public members, and encouraged interested parties in applying for appointment. Mr. Rayfield noted that the deadline for applying for appointment to the Ocean Water Quality Subcommittee would be Friday, April 15th.

Mayor Rayfield reported that the next meeting of the City Council would be held on April 27, 2005, in the Dana Point Community Center located at 34052 Del Obispo Street, Dana Point, California, where a joint meeting with the Planning Commission will be held in addition to customary City Council business.

Mayor Rayfield reminded everyone that Saturday, April 23rd is Earth Day, during which time residents may receive free mulch provided by CR&R at the Lowe's Center in Aliso Viejo.
