She noted she had sent a follow-up e-mail to the Board restating the City's position on these issues.

Mayor Pro Tem Anderson reported she had toured the South Orange County Wastewater Authority (SOCWA) facilities on February 25th and was impressed with their well-run organization.

Mayor Pro Tem Anderson noted the Lantern Village Association (LVA) held their annual meeting on March 1st and stated it was good to see the LVA and the City working together.

Mayor Pro Tem Anderson reported on her recent attendance at both the residents' and business owners' Town Center Workshops and encouraged everyone to submit comments and participate in the workshops.

Mayor Pro Tem Anderson reminded everyone of the Wag-A-Thon sponsored by the Pet Project Foundation to be held this coming weekend on March 12th.

Mayor Pro Tem Anderson reported on her attendance at the tribute to military veterans held after the Festival of Whales parade on Saturday, March 5th and commented on the moving speech made by Mayor Rayfield at the event.

Mayor Pro Tem Anderson reported the Dana Point Yacht Club would be taking injured Marines just back from Iraq on a fishing trip this coming weekend.

Mayor Rayfield commented on his optimism for the support of Congressman Cox and Congressman Hobson in the City's grant request to the Environmental Protection Agency (EPA).

Mayor Rayfield noted that Sunday, March 13th was Ocean Awareness Day and invited everyone to visit the City's booth.

Mayor Rayfield commented on the well-attended recent Town Center Workshops, thanked those who had provided comments and encouraged input regarding the future Town Center project.
