18. NO SMOKING IN PUBLIC PLACES ORDINANCE

Denise Erkeneff, Dana Point, stated she supports the smoking ban in public places because it will be better for ocean quality. She read statements from two Dana Hills High School students, Armon Ashoubi and Michelle McKee, who are also members of Surfrider stating they support the smoking ban.

Mary Hartmann, Dana Point, stated she is in favor of the smoking ban and is in agreement with Denise Erkeneff's comments. She stated that she is a steward for the "Zero Trash Dana Point" campaign.

Kristin Sonnenschein, Dana Point, stated she is shocked in how much smoking has come back and noticed the amount of cigarette butts that she picked during her first clean up event she participated in this year. She said she is in favor of the smoking ban.

Hoiyin, Dana Point, she stated that she was surprised to hear about the smoking ban. She said that she took it upon herself to survey people at the Farmer's Market over the weekend to obtain signatures to support the smoking ban. She provided a copy of the signatures she received.

Dr. Douglas Harrington, American Lung Association and American Heart Association, stated facts about the dangers of smoking and felt that by empowering your residents to prevent someone

from smoking it would make a greater impact on overall health for the City and encouraged the City Council to support the smoking ban.
