Maurine Lacher, Dana Point, owns Dana Point Art Center and invited the City Council to the next "Fantasea of Art" on September 9, from 2:00 – 8:00 p.m. at the Blue Lantern Plaza.

Dr. Jim Seitz, Dana Point, spoke about the General Plan Amendment for Makar that was approved by Council on June 24th and June 28th. He believes that the action taken on June 28th violated the Brown Act and is not legal/valid.

Kathleen Lebon, Mission Viejo, introduced herself as a candidate of District 7 for the Capistrano Unified School District.

Lisa Bartlett, Capistrano Beach, introduced herself as a candidate for the Dana Point City Council and provided her email address www.Lisa4DP.com.

Joel Bishop, Dana Point, thanked the Chief of Police and his deputies for their swift action in capturing the drunk driver that hit his car a couple of months ago.

Judy Rice, Laguna Hills and Hemet, mentioned that another former Dana Point Mobile Home Park resident, ex-manager Donna, died and is concerned about a Negative Declaration on the Mobile Home Park property.

21. PARKS AND RECREATION FACILITIES REGULATIONS

City Manager Chotkevys provided a staff report and indicated that the City of Dana Point would be accepting Lantern Bay Park from the County of Orange on September 1, 2006.

Director of Administrative Services Apodaca provided an overview of the Park Use policy and recommended revisions.

Lisa Bartlett, Capistrano Beach, requested that Pines Park be classified as one through three (200 persons maximum) instead of one through four (1000 persons maximum).

Richard Gardner, Capistrano Beach, spoke in favor of a skateboard park in Dana Point before eliminating skateboarding at Del Obispo Park.

Recreation Manager Evans responded to City Council questions.

Council Member Harkey indicated she would prefer Pines Park be classified as one through three, except for City sponsored concerts, and hold other larger events at Lantern Bay Park.

City Council discussed other ideas for skateboarding in Dana Point. City Manager Chotkevys suggested portable skateboard units for trial in various areas of the city and to bring back skateboarding at Del Obispo Park at a future meeting.

IT WAS MOVED BY COUNCIL MEMBER HARKEY, SECONDED BY COUNCIL MEMBER RAYFIELD TO CHANGE THE CLASSIFICATION TO ONE THROUGH THREE AT PINES PARK, EXCEPT FOR CITY SPONSORED EVENTS, AND INTRODUCED AND HELD FIRST READING OF AN ORDINANCE ENTITLED:

Director of Public Works /City Engineer Fowler provided a staff report and PowerPoint presentation on various designs for this project.

Jim Wilson of 30th Street Architects responded to questions from City Council on the pedestrian access way designs.

Richard Gardner, Capistrano Beach, spoke about the people coming from Capistrano Beach into Dana Point, how they would be able to use this access way, and fix the pedestrian problems in the community first.

Council Members spoke in favor of the recommended concept design and Council Member Lacy would like to include City branding (i.e. City seal, motto, etc.), possible. Mayor Anderson asked that appropriate lights would be added to this access way so it so it can be seen at night.

David Swerdlin, representing the owners, provided pictures with various designs and roof heights, the owners provided and option with a flat roof, and asked for approval of the recommended action prepared by staff.

Mayor Anderson closed the Public Hearing.

Council Member Harkey presented pictures while discussing various alternatives and thought the options were not feasible.

City Council Members discussed their views on this project. Council Member Rayfield would like the City to revisit public views (versus private views). Council Member Lacy indicated he supported the appeal because of the statement in our ordinances and codes about compatibility in the community.
