Subcommittee Member Rayfield provided the Subcommittee with an update on research being conducted by the South Coast Water District and the City of San Juan Capistrano on a suspected barrier under the San Juan Creek near Stonehill Drive. **No action required.**

A letter of support of Assembly Bill 1884 (Single-Use Plastic Straw Ban) was requested by Subcommittee Chair Wyatt. The subcommittee agreed. A draft letter of support to be presented to the Subcommittee at the next meeting.

Rick Erkeneff of the Surfrider Foundation South Orange County Chapter indicated that he had noticed a large amount of tar accumulating on Dana Point Beaches. Subcommittee Chair Wyatt suggested having the tar tested to determine origin (natural seepage or a spill). *City to investigate testing protocol and feasibility.*

Subcommittee Member Rayfield provided an update on an enzyme that was found that breaks down plastic. *Provide article to Subcommittee Members via email.*
