# 8. CONTRACT AGREEMENT RENEWAL BETWEEN ALL CITY MANAGEMENT SERVICES, INC. AND THE CITY OF DANA POINT FOR PROVIDING SCHOOL CROSSING GUARD SERVICES

AUTHORIZED THE CITY MANAGER TO APPROVE THE RENEWAL OF CONTRACT AGREEMENT BETWEEN ALL CITY MANAGEMENT SERVICE, INC. AND THE CITY OF DANA POINT FOR PROVIDING SCHOOL CROSSING GUARD SERVICES FOR FISCAL YEAR 2018-19.

# **PUBLIC COMMENTS**

Wayne Yost, Dana Point, thanked the City for support of the Memorial Day service. He spoke regarding the homeless work plan as he had served on the task force. He reported that Bob Fowler was in critical condition in Mission Hospital.

Deborah Lord, Dana Point, spoke regarding her concerns with the bikers that are using Creekside Park as a detour.

Julie Simer, Dana Point, reported that the last concert for the Dana Point Symphony was this Saturday night at St. Edwards where they will be celebrating the end of their 7th season. She stated that it could not have been done without the support of the City Council. She encouraged everyone to attend.

Kal Peters, Capistrano Beach, spoke regarding the short term rental program and shared her concerns.

Nancy Jenkins, Dana Point, announced the upcoming ArtFest on Del Prado on Sunday where almost 100 artists would be participating. She stated that it would be coinciding with the beginning of the trolley.

Tim Kuhlman, Dana Point, spoke regarding a concern he has over a security light installed in the Niguel Beach Terrace development over a month ago. He asked for the light to be shielded and redirected away from their homes.

# COUNCIL REPORTS, INCLUDING CITY RELATED MEETINGS ATTENDED

Council Member Tomlinson stated that he would turn in his list of meetings attended.

Council Member Wyatt stated that he had turned in his list of meetings to the City Clerk. He added that he had included a brief summary of the meeting with the OC League of Cities on homelessness along with Mayor Pro Tem Muller. He stated that the purpose of the meeting was to present the latest updates from the federal resources available to help local governments tackle homelessness, the latest homelessness legislation being debated in the state capital and the latest actions being taken by the County of Orange. He stated that the League and Cities and the Institute of Local Governments has just released a report titled "Homelessness Task Force Report, Tools and Resources for Cities and Counties". He added that the publication was available on the League of Cities website <a href="https://www.cacities.org">www.cacities.org</a>.

Council Member Lewis stated that she would turn in her list of meetings attended. She reported that she had gone on a ride-a-long with one of the deputies last week. She thanked Deputy Merz for taking her along with him and she found that the City has a very dedicated police force.

Mayor Pro Tem Muller suggested that the Council take a look at the committees and create a non-voting position so we can take advantage of their expertise so they would not restricted by the Brown Act. He asked that an item regarding this issue be put on the June 19<sup>th</sup> agenda for discussion. He reported that he and Dick Sergeant had been discussing that next year will be the 35<sup>th</sup> anniversary of when the Olympic Torch ran through Dana Point and how they would like to organize another torch run. He stated that he would like to have Mr. Sergeant attend the meeting on the 19<sup>th</sup> to discuss the run. He added that he is in contact with many US Water Polo Directors and that they are actively looking for a place that would serve as their training facility. He stated that they were interested in the bus yard. He spoke regarding the voting record on development impact fees for the toll roads and how they were falsely reported at the last meeting. He reported that the on June 12, 1997, the TCA boards passed resolutions that put in place automatic annual adjustments to the development impact rates which adjust annually at the beginning of the fiscal year. He added that he would turn in his list of meetings attended to the City Clerk.

Mayor Viczorek stated that he would turn in his list of meetings attended to the City Clerk. He thanked Wayne Yost for his comments and is always very complimentary of the City. He added that the City does not have the opportunity to thank the VFW and Wayne for his leadership of the organization. He stated that on behalf of the City and everyone here our thoughts and prayers are with Bob Fowler and his family.

Council Member Wyatt stated that the Homeless Task Force had non-voting members and felt that it would be a great idea for the other committees.

Brief Summary of the League of California Cities Homelessness Symposium Presentations by:

- Helene Schneider, United States Interagency Council on Homelessness
- Jason Rhine, League of California Cities Housing Lobbyist
- Frank Kim, County of Orange Chief Executive Officer

These presentations provided the latest updates on federal resources available to help local government tackle homelessness, the latest homelessness legislation being debated in our State Capital, and the latest actions being taken or contemplated by the County.

The "Homeless Task Force Report – Tools and Resources for Cities and Counties" recently published by the California League of Cities and Institute for Local Government was also distributed and discussed. This publication is available at the League of Cities web site cacities.org.

I took away three (3) key messages from this meeting:

- A path for the cities, county and non-profits to work together must be found.
- Strong, determined leadership is essential for this effort to succeed.
- Even with hard, dedicated, focused efforts it will take two (2) years to build the components that are needed to address homelessness.
