# Report on Key Takeaways from meetings on Homelessness

In the two weeks since our last Council Meeting, I've attended four more meetings on homelessness. This report documents some of my key takeaways from these meetings.

Andree Bailey, head of a public-private partnership to end homelessness in Orlando, Florida:

- Homeless has become so prevalent that it cannot be hidden, and it will ultimately decimate a city's economy if it is not ended.
- Homelessness is best viewed as an infrastructure issue that is expensive and complex to solve.
   Think of it as building a new freeway across the county it will take that kind of partnerships and determination.
- Throwing money at the problem without accountability will fail and will be a terrible waste of money and delay the solution.

## Dana Point Community Forum on Homelessness

- The Doheny Feed creates a public nuisance that the City needs to take the lead in ending. Excuses are not acceptable. If we don't have the legal right to force it to end, then work with the sponsors to find an acceptable alternative but lead.
- Don't hesitate to call the police if you are concerned about a homeless person. The police will work jointly with the City's Care Coordinator to assess the situation. Every contact made by the Care Coordinator with the homeless is useful.

## ACC-OC Homelessness Partnership Dinner

The Mayors and City Managers from all thirty-four Orange County cities were invited to this dinner along with key staff and elected officials from the County. Thirty-one of the cities were represented. The intent of this meeting was to ask all the cities in Orange County to commit to:

- A coordinated regional solution
- Collaborate on the design of a regional solution
- Help Susan Price, Orange County Director of Care Coordination for the Homeless, build out her system
- Invite Orange County Mental Health to present a world-class solution
- Lead the effort to permit, site and help finance two thousand, seven hundred units of permanent supportive housing.

And a closing statement from Andree Bailey worth taking to heart: "When you stop making excuses and evaluate who you are, you will solve this problem".
