Carol Wilson, Capistrano Beach, asked for future agendas to be arranged to allow for public participation.

Wayne Yost, Dana Point, spoke regarding the other cities that were suing the State of California over Proposition 54 and felt that it was time for Dana Point to take a stand on the issue.

Bob Oakley, Dana Point, spoke regarding the recycling center next to Ralphs on Del Prado the noise that the neighboring homes have to endure.

Chad Kurthy, Rancho Santa Margarita, spoke regarding the Board of Directors attempting to decrease the daily staffing from 24 hour shifts to 12 hour shifts.

Paul Merritt, Laguna Beach, spoke of the recent removal of 22 mature trees on Pacific Coast Highway and felt that their removal was a violation of the specific plan.

Kathy Joshua, Dana Point, spoke regarding the general conduct at the Council meetings.

Ross Teasley, Dana Point, spoke regarding the proposed districting and the general distrust in the City.

Julian Joshua, Dana Point, spoke regarding the by-district elections.

Alan Bell, Capistrano Beach, spoke regarding the by-district elections.

Mark Zanides, Dana Point, spoke regarding the order of the agenda and felt that Item 15 should be moved up in the order.

# COUNCIL REPORTS, INCLUDING CITY RELATED MEETINGS ATTENDED

Council Member Tomlinson asked for an item to be added to the next agenda regarding Proposition 54.

Council Member Wyatt stated that he had turned in his list of meetings to the City Clerk. He provided a summary of the last homeless task force meeting.

Council Member Lewis responded to comments made regarding districting and read the following statements into the record:

"Every decision carries some risk. Rushing to the "safe harbor" risks enmity and unwanted political ramifications. Good advice is rational, well reasoned and balanced. It presents all options and quantifies various risks. Instilling fear without quantifying incremental risk does no good service. In fact, it does harm.

147 California cities elect At-large Mayors. Palmdale and Anaheim listed in the staff report elect At-large Mayors. A lengthy quote in the staff report from Rancho Cucamonga case claims the matter is unsettled. The case settled. Rancho Cucamonga is electing an At-large Mayor.

Let's explore all of the options in a neutral fashion and stop the fear tactics."

Mayor Pro Tem Muller responded to the comments made regarding OCFA 911 dispatchers and their contract. He provided the background of the labor negotiations and stated that if anyone had any questions they should contact the OCFA Communication and Public Affairs Battalion Chief, Marc Stone at 714-573-6028 or email at marcstone@ocfa.org. He stated that he would turn in his list of meetings attended to the City Clerk.

Mayor Viczorek stated that he had turned in his list of meetings to the City Clerk. He responded to comments regarding the ordering of items on the agenda and explained that Item 15 was placed on the agenda after he had already approved it. He added that it was his intention when he received the agenda packet to hear both items together.

City Attorney Munoz provided a staff report for Item 11 and Robert McEntire from NDC provided a PowerPoint presentation.

Brief discussion ensued.

Council Member Lewis provided a staff report for Item 15.

Mayor Viczorek opened the Public Hearing.

Sandie Iverson, Capistrano Beach, spoke regarding the need to keep communities intact.

Carol Wilson, Capistrano Beach, spoke in opposition of the districting. She stated that she did not care for any of the maps except maybe the Pine map.

Alan Bell, Capistrano Beach, spoke regarding the maps that divide Capistrano Beach.

Toni Nelson, Capistrano Beach, spoke regarding the history of Capistrano Beach and felt that the area should not be divided.

Karen Lloreda, San Clemente, spoke regarding the history of Dana Point's incorporation. She recommended that the City move forward and hold more public meetings for real discussion.

Karen Ezell, Capistrano Beach, asked if there was any proof regarding racially polarized voting. She stated that she would support four districts with an at-large Mayor similar to the Pine map.

Michael Kay, Capistrano Beach, spoke regarding districting and the impact it could have on the November election.

Lenger Markus, Capistrano Beach, spoke regarding districting and the Council's fiduciary duty to the City.

Bob Oakley, Dana Point, stated that his community objected to the Tan and Oak maps as they would isolate their community of Lantern Bay Villas.

Barbara Wilson, Dana Point, spoke regarding district voting and the residents need for answers. She did not understand the maps that split Capistrano Beach. She stated that she supported workshops on this issue.

Ardyce Kehiayan, Dana Point, spoke regarding the districting and how it would create division and disenfranchise voters.

Judy Reising, Capistrano Beach, felt that the proposed maps did not represent their area and that there were not enough facts to make a decision tonight.

Julian Joshua, Dana Point, stated that there was no way to split Dana Point without causing issues and that he was not in favor of districting.

Buck Hill, Capistrano Beach, felt that there has not been enough done to encourage community involvement in this issue. He added that open meeting were needed where the questions could be asked.

Amy Hanacek, Capistrano Beach, encouraged the Council to follow Council Member Lewis' suggestions for workshops. She stated that if need be, she would support an at-large Mayor.

Richard Thompson, Dana Point, felt that the district elections would not solve the problem of uneven representation.

Michelle Baca, Dana Point, felt that the City needed to take its time in making decisions regarding the district elections.

Mark Zanides, Dana Point, felt that the Council was being misled on this subject and that it would be important to have an at-large Mayor.

Nadia Starner, Capistrano Beach, stated that she was opposed to districting and that the dismantling of the communities would only create larger walls. She asked for more communication with the public.

Steve Stewart, Dana Point, felt that the City was rushing this issue and that a negotiation similar to Mission Viejo should be pursued.

Lawrence Robinson, Capistrano Beach, stated that he would like to ensure that Capistrano Beach was not split to maintain its identify and that four districts with an at-large Mayor would be appropriate.

Karl Williams, Dana Point, spoke regarding the proposed districting and asked the Council to think about the citizens.

Bev Jorgensen, Executive Director of the Dana Point Chamber of Commerce, stated that they supported one public forum outside of the Council meetings to discuss the proposed districting.

Mayor Viczorek closed the Public Comments.

Discussion ensued.

Council Member Wyatt made a motion to set dates for one if not two public forums, Council Member Lewis seconded the motion.

Discussion ensued.

Mayor Pro Tem Muller made a substitute motion for the next four Council meetings to be used as open forums. The motion died for a lack of a second.

# Homeless Task Force March 26, 2018 Meeting Report

I am pleased to report that at the March 26 Homeless Task Force Meeting, the Task Force voted to bring the "Community Work Plan to Address Homelessness" to the City Council for consideration.

As you know, in Aug 2017, the Task Force at my director and Council's concurrence was dissolved and reconstituted with the defined purpose of bringing a plan to the City Council to address homelessness in

Dana Point. Specifically, the stated purpose was: "By working jointly with our neighboring cities, the County of Orange, and other engaged public agencies, and working through non-profit organizations that provide services to the homeless, create a sustainable, measurable program to eliminate the necessity of in the Dana Point regional area". Taking input from the Task Force, the City staff drafted and revised a work plan to meeting this purpose. On March 26<sup>th</sup>, agreement was reached that with minor revisions, the Work Plan is ready for review by the City Council.

With the actions already suggested by the Task Force and adopted by the City, Dana Point is prepared to respond to the directions coming from the Santa Ana court room of Judge Carter. I especially want to acknowledge the work done by Kelly Reenders to support the task force, create the Work Plan, and work with our Care Coordinators, Mercy House and FAM, and with our Faith Based Leaders to get homeless services underway.

I look forward to taking the Council's feedback and subsequently the publics' feedback to back to the Task Force to help finalize the Work Plan.
