# South OC Service Planning Area (SPA) Meeting on Homelessness

The South County Service Planning Area (SPA) meeting was held on Monday September 24th. City Manager Mark Denny, Kelly Reenders and I attended and received some good news. Contrary to our previous understanding, the funding from the state, \$15M for OC – Homeless Emergency Assistance Program (HEAP), only requires a city to declare a homeless crisis if the requested monies are to be used for location-specific projects such as siting and building a homeless shelter. The state is now saying that other projects such as outreach and rapid rehousing do not require a resolution if done though a non-profit service provider.

Mark and Kelly recognized this opportunity immediately and organized a meeting of the five neighboring cities in South County who use Mercy House for outreach to discuss a grant for these funds. The first meeting has already taken place with very positive results and a second meeting is scheduled for later this week.

The grant application must be submitted by Friday. Kelly has taken the lead on making this happen with support and assistance from Mark. The County will make the determination on the money but thanks to Kelly's and Mark's leadership four of our neighbor cities are now working together with Dana Point to address the homelessness issues in our regional area. I think this grant application has a very high possibility of being funded and I especially want to thank Kelly for recognizing the opportunity and doing the heavy-lifting to pull our neighbors together to make this possible.
