On 4/24/2109, the 2019 Point-in-Time Count of the homeless in Orange County was made public. On 4/30/2019, Mayor Muller, City Manager Denny and I attended a meeting of South Orange County Cities, hosted by Orange County Supervisor Lisa Bartlett to review the Count numbers and discuss the implications. On 05/01/2019, I participated in the Orange County Commission to End Homelessness where the Point-in-Time Count results were discussed in detail again. Both meetings communicated: (1) this is a count of the homeless at a point in time to measure the work yet to be done, but does not assess nor measure the work that has already been done, and (2) homelessness is a regional problem that must be solved at the regional level and although the count does break the results down by cities, it does not score city achievement.

On 4/25/2019, I participated in the Orange County Public Libraries Advisor Board review of the proposed FY2019-2020 budget. With projected revenue of \$60,525,743, proposed budget expenses of \$60,439,478 and the Irvine Set-aside of \$4,504,463, they will need to move \$3,913,735 from the FBU to cover the proposed budget. The FBU balance will drop to \$28,041,161 so there is not panic but there is agreement that this must be addressed with a plan to balance future budgets.
