PUBLIC COMMENTS

Joe Jagger (Monarch Beach) stated his disapproval of the Dana Point Taxpayers Association (DPTA) using City assets such as trolley services and signage and proposed questions of the planning, purpose, and outcome of the event.

Cassandra Andreas (Monarch Beach) stated that she is disappointed in the Trolley Hop activity and raised questions of where the money collected went.

Carol Wilson (Capistrano Beach) stated that once she discovered that the Dana Point Taxpayers Association was involved with the Trolley Hop she changed her plans and questioned the legality of the event and beneficiaries.

Carol Wilson read a statement from Charles Payne (Dana Point) stating that the Trolley Hop appeared to be a City event because of marketing pieces and advertising placement.

Wayne Yost (Dana Point / Commander of VFW Post 9934) stated that Dana Hills High School will again be hosting the Honor The Valor Football Game on September 13th and distributed a flyer for the event. Additionally, he encouraged residents to contact the U.S. House of Representatives and urge them to sign the bill providing benefits to first responders of 9/11.

Mark McGinn (Dana Point) stated that the DPTA ran ads that stated false information about him and stated his disapproval of the use of the trolleys for such an event.

Rory Hood (Dana Point) stated that he purchased a home in Dana Point with the intention to use it as a Short Term Rental when they are not living in California and encouraged Council to allow permits to be issued again.

Toni Nelson (Capistrano Beach) stated that the flyers for the Trolley Hop were intended to look like a City event and questioned the vetting of the event by the City.

Betty Hill (Dana Point) listed the donors to the Dana Point Tax Payers Association.

Hoyin Ip (Dana Point) spoke in favor of banning Styrofoam coolers.

Steve Stewart (Dana Point) stated as a business owner he would never have chosen to participate in the Trolley Hop if he knew it was sponsored by the Dana Point Tax Payers Association and spoke in opposition of their practices.

stated that City codes were violated when the signs were posted on the trolley sign posts for days and questioned if the City was now subject to a lawsuit. She stated that the City must never allow this to happen again.
