risks to the San Onofre Interim Spent Fuel Store Infrastructure (ISFSI), and responses. This will include natural and manmade events, potential consequences, remedies and levels of emergency response. It will cover the basics of radiation as it is key to understanding potential consequences explained by expert panelists who understand potential events and the design of the dry fuel storage systems in place at San Onofre.
