ITEM 5: Doheny Village Mural - Call for Artists

Reenders reminded the Commission that the City Council has asked the Arts and Culture Commission to assist with some of the mural projects in Doheny Village. The mural project proposed at the corner of Doheny Park Road and Las Vegas Avenue at the U.S. Post Office building owned by Robert Chade. Funding would come from Doheny Village Capital Improvement Reserve Fund. Reenders asked the Commission to consider recommending a Call for Artists be developed to solicit proposals for the mural and a second action to form an ad-hoc subcommittee of two Commissioners, together with the building owner to evaluate proposals prior to going to City Council for recommendation.

Discussion ensued among the Commissioners.

ACTION Motion made (Banks) and seconded (Jenkins) to recommend that the City develop a Call for Artists to solicit for the mural project on the corner of Doheny Park Road and Las Vegas Avenue at the U.S. Post Office building. Motion carried 4-0.
