Donna Kalez (Dana Wharf Sportfishing) spoke of her concerns with the proposed California Air Resources Board (CARB) regulations and the negative impact they would have on her business.

Ken Franke (Sportfishing Association of California) provided a Power Point Presentation illustrating the negative impacts the proposed CARB regulations would have and asked for the support of the City Council.

Vickie McMurchie (Dana Point Chamber of Commerce) spoke in support of the Sportfishing Association of California and announced that the Chamber of Commerce Board of Directors voted to join the Coalition Opposed to CARB regulations.

Jim Holden (Fish for Life) spoke in support of the sportfishing industry and Dana Wharf Sportfishing and asked for the City Council's support in opposing the proposed Regulations.

Hoyin Ip (Sierra Club) spoke with concerns regarding air quality and the emissions from boats and urged the City Council to invite CARB to speak.

A FRIENDLY AMENDMENT WAS MADE BY MAYOR JAMEY M. FEDERICO, AND ACCEPTED BY JOSEPH L. MULLER, THAT THE CITY COUNCIL TAKE AN OPPOSED POSITION AGAINST THE PROPOSED REGULATIONS AND SEND A LETTER TO THE GOVERNOR. MAYOR JAMEY M. FEDERICO SECONDED THE MOTION.
