ISSUES

1. Does the proposed public art component fulfill the purposes of the Art in Public Places Program to enhance the cultural and aesthetic environment of the City and encourage appreciation of the arts and our cultural heritage?

2. Is the proposed art an enhancement to the site, surrounding neighborhood and the City as a whole?

BACKGROUND

The Prado West mixed-use project was approved by the City Council on October 21, 2014 consisting of seven non-contiguous lots featuring 32,500 square feet of ground floor retail space, 109 residential units, and two levels of subterranean parking in two separate facilities: one under Buildings 1, 2, and Amber Lantern and the other under Building 3.

Art in Public Places Program

The "Art in Public Places" (AIPP) Program was instituted in 1994 with the purpose to enhance the City's cultural and aesthetic environment in accordance with goals and policies of the Dana Point General Plan—Urban Design Element and the Dana Point Community Cultural Plan. The value of public art is also recognized in the Town Center Plan, as reflected in Policy 2.6: "Incorporate art features, including public art as an element of development and enhancements."

The AIPP applies to all new development with total construction costs of over one million dollars, and the minimum value of the public art provided for a project shall equal one-half (0.50) percent of the project's total construction costs. Though no specific themes are mandated for the public art component, the Zoning Code does list possible thematic content for the public art component of a project including coastal/marine lifestyle, history of the City of Dana Point, archaeology and paleontology of the natural environment of the area, and cultures of indigenous peoples of the area. Public art shall include but not be limited to sculptures, paintings, graphic arts, mosaics, photographs, fountains, decorative arts, film and video, and preservation of features or resources of historical, archaeological or paleontological significance and are encouraged to be representational and non-representational.

The public art should also be prominently placed within a development and oriented toward the pedestrian experience of the site with specific consideration given to making the public art accessible to people with disabilities. The design should also showcase the public art by providing viewing opportunities from many angles and utilizing site landscaping and lighting to complement and enhance the work.

The project's total construction cost is approximately \$56,753,637 resulting in a minimum value cost requirement of \$283,768 for the public art component of the project.

The proposed art program was introduced to the Planning Commission on August 9, 2021, and the Arts and Culture Commission on October 13, 2021. No formal action was requested of the Commissions. Following a presentation from the applicant, each Commission asked clarifying questions. The Arts and Culture Commission expressed

general support for the concept, specifically as it relates to opportunities to support artist and offering of local music.

DISCUSSION

The applicant proposes the on-site installation of public art and cultural activities to meet the AIPP requirement for the Prado West Mixed-Use project. The project design focuses the public experience at the outdoor area created at the western most building on Amber Lantern, referred to as Prado Square. Therefore, two of the three art features are proposed within the area. The third art feature, a mural, would be located on Del Prado.



The applicant's proposal is included as Supporting Document 2 and is summarized below:

Rotating Art Halls (Halls of Public Expression – HOPE) – Featuring of nine 8' x 12' unique art pieces within the two halls that connect pedestrians from Pacific Coast Highway and Del Prado to the Public Square, providing an open-air experience. Art may include paintings, mosaics, graphic arts, or photographs. The project budget supports program implementation for a two-year period during which the art will be managed by Bryan Snyder, a Southern California arts curator. Mr. Snyder will curate the artists and information will be posted in the hallways on how artists can participate. The first three art installations will occur by the end of 2021 and will be rotated approximately quarterly. After being featured, the art piece will be auctioned, creating a potential revenue stream that could extend the project beyond two-years.

Music Performance Event – Raintree intends to partner with the Music Preserves Foundation to host a small-stage performance with ancillary interview and education opportunities within the Prado West Public Square at the end of 2023. But, the goal is to ensure a number of artists will be hosted at the site that will be part of the various community events that occur in Town Center, such as Re-do market.

Del Prado Lantern Mural – Located on the exterior wall overlooking Del Prado and the post office, the mural will be created by Artist Drew Merritt who is recognized for creating photo realistic pieces. The mural will be treated with a clear protectant coat to ensure the color and clarity of the mural is protected for approximately 15 years. A unique element of the mural is use of an Augmented Reality (AR) function that creates another dimension to the mural via a phone and QR code (to be displayed in a plaque located below the mural). The mural will depict a copper lantern, as shown below, but the AR would reveal ships and dolphins behind the lantern. The mural and AR are expected to be installed by the end of 2021.



Budget Allocation

The AIPP applies to all new development with total construction costs of over one million dollars, and the minimum value of the public art provided for a project shall equal one-half (0.50) percent of the project's total construction costs. The project's total construction cost is approximately \$56,753,637 resulting in a minimum value cost requirement of \$283,768 for the public art component of the project. Allocation of the required project budget detailed in Table 1.

Since the rotating art halls and music performances are ongoing elements of the program, the project has been conditioned requiring Raintree to provide the City with documentation of expenses. If at the end of the two-year period the funds have not been fully expended, as determined acceptable to the City of Dana Point, continuation of the program will be evaluated. If the City determines that the program is not meeting the intent of the purpose of the AIPP detailed in Zoning Code Section 9.05.240, then the remaining funds shall be submitted to the City.

Zoning Code Section 9.05.240(e)(5) sets forth requirements and findings to be used as the basis for approving the public art component. The required findings are listed below with staff analyses:

1. That the work fulfills the purpose of the Art in Public Places Program.

The purpose of the AIPP Program is to enhance the cultural and aesthetic environment of the City, and to encourage creativity, education and an appreciation of the arts and Dana Point's cultural heritage. The proposed art

program offers a multisensory experience of music, art, and public engagement. Therefore, the proposed art installation and program fulfills the purpose of the "Art in Public Places" Program.

2. That the work is an enhancement to the site, surrounding neighborhood and the City as a whole.

The lantern mural is reflective of the City's culture and history and is located at a prominent location on Del Prado, creating visual interest to passing motorists and pedestrians. The rotating art will draw pedestrians into the halls and into Prado Square, offering visual enhancements through the art pieces and cultural events. Therefore, the proposed public art components will enhance the aesthetic environment of the project, its immediate vicinity, and the City as a whole.

CONCLUSION

The proposed artistic enhancements to the Prado West Mixed-Use project comply with the AIPP Program. Artistic theme, material, placement and location will be enjoyed by pedestrians, bicyclists and motorists. The applicant has also complied with the required timing for the submittal and review of the proposed public art components and approval of said public art components satisfies condition of the original entitlements, which will be installed prior to final certification of occupancy for the new buildings. The cost of the implementing the program complies with the minimum amount required by the Zoning Code. Therefore, Staff recommends that the Planning Commission adopt the attached draft resolution, approving the public art program for the Prado West Mixed-Use Project.

A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF DANA POINT, CALIFORNIA, APPROVING THE PUBLIC ART COMPONENT FOR THE PRADO WEST MIXED-USE PROJECT.

The Planning Commission for the City of Dana Point does hereby resolve as follows:

WHEREAS, Raintree Partners (the "Applicant") is the owner of real properties 34135 Pacific Coast Highway/34201 Amber Lantern/24471 Del Prado (Building 1); 34137 Pacific Coast Highway/34200 Amber Lantern/24501 Del Prado (Building 2); and 34155 Pacific Coast Highway/34185 Violet Lantern/24591 Del Prado (Building 3) (the "Properties"); and

WHEREAS, the Applicant has made an application for the on-site installation of public art and cultural activities in compliance with the Art in Public Places (AIPP) program at the Properties; and

WHEREAS, said verified application constitutes a request as provided by Title 9 of the Dana Point Municipal Code; and

WHEREAS, Pursuant to the California Environmental Quality Act (CEQA), the project is categorically exempt per Section 15061 (b)(3) of the CEQA Guidelines – in that the proposed activity will cause no significant effect on the environment and is therefore not subject to the California Environmental Quality Act (CEQA); and

WHEREAS, the Planning Commission did, on the 25th day of October, 2021, hold a public meeting to consider said request; and

WHEREAS, at said public meeting, upon considering all testimony and arguments, if any, of all persons desiring to be heard, said Commission considered all factors relating to the Art in Public Places component for the Prado West Mixed-Use project approved by the City Council on October 21, 2014.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Planning Commission of the City of Dana Point as follows:

- A) The above recitations are true and correct and incorporated herein by this reference.
- B) Based on the evidence presented, the Planning Commission adopts the following findings and approves the public art components of the Gloria Dei Lutheran Church remodel and expansion project, subject to conditions:
 - 1. That the work fulfills the purpose of the Art in Public Places Program (AIPP) in that the purpose of the AIPP Program is to enhance the cultural and aesthetic environment of the City, and to encourage creativity, education and an appreciation of the

> arts and Dana Point's cultural heritage. The proposed art program offers a multisensory experience of music, art, and public engagement. Therefore, the proposed art installation and program fulfills the purpose of the "Art in Public Places" Program.

2. That the work is an enhancement to the site, surrounding neighborhood and the City as a whole in that the lantern mural is reflective of the City's culture and history and is located at a prominent location on Del Prado, creating visual interest to passing motorists and pedestrians. The rotating art will draw pedestrians into the halls and into Prado Square, offering visual enhancements through the art pieces and cultural events. Therefore, the proposed public art components will enhance the aesthetic environment of the project, its immediate vicinity, and the City as a whole.

Conditions:

- 1) Approval of this application is to allow the on-site installation of public art components as depicted in Supporting Document 2 of the October 25, 2021, staff report for this request and in compliance with condition of approval number 145 of Resolution 14-10-21-03, and in accordance with Section 9.05.240 ("Art in Public Places" Program) of the Dana Point Zoning Code (DPZC) for the Prado West Mixed-Use project. The project's total construction cost was estimated to be \$56,753,637; resulting in a minimum value cost requirement of \$283,769 for the public art component of the project.
- 2) Failure to abide by and faithfully comply with any and all conditions attached to the granting of this permit shall constitute grounds for revocation of said permit.
- 3) The applicant or any successor-in-interest shall defend, indemnify, and hold harmless the City of Dana Point ("CITY"), its agents, officers, or employees from any claim, action, or proceeding against the City, its agents, officers, or employees to attack, set aside, void, or annul an approval or any other action of the City, its advisory agencies, appeal boards, or legislative body concerning the project. Applicant's duty to defend, indemnify, and hold harmless the City shall include paying the City's attorney's fees, costs and expenses incurred concerning the claim, action, or proceeding.

The applicant or any successor-in-interest shall further protect, defend,

> indemnify and hold harmless the City, its officers, employees, and agents from any and all claims, actions, or proceedings against the City, its offers, employees, or agents arising out of or resulting from the negligence of the applicant or the applicant's agents, employees, or contractors. Applicant's duty to defend, indemnify, and hold harmless the City shall include paying the City's attorney's fees, costs and expenses incurred concerning the claim, action, or proceeding.

> The applicant shall also reimburse the City for City Attorney fees and costs associated with the review of the proposed project and any other related documentation.

- 4) The applicant and applicant's successors in interest shall be fully responsible for knowing and complying with all conditions of approval, including making known the conditions to City staff for future governmental permits or actions on the project site.
- 5) The applicant and applicant's successors in interest shall be responsible for payment of all applicable fees along with reimbursement for all City expenses in ensuring compliance with these conditions.
- 6) The maintenance of the public art for the Prado West Mixed-Use project shall be the responsibility of the applicant (Raintree Partners) and the applicant's assigns and successor's-in-interest.
- 7) Prior to the issuance of a Certificate of Use and Occupancy for at least one of the three buildings for the Prado West Mixed-Use project, the applicant shall install the Del Prado Lantern Mural and the infrastructure for the rotating art program.
- 8) The applicant shall submit quarterly reports to the Community Development Department detailing project implementation and documenting project expenses.
- 9) If by December 2023, the project budget has not been expended in accordance with this approval, remaining funds shall be submitted to the City of Dana Point as an in-lieu art fee as defined by DPZC 9.05.240.

The program also serves to implement a number of goals and policies of the Dana Point General Plan Urban Design Element and Town Center Plan ACTION: Response as follows

Purpose: To enhance cultural aesthetic and environment of the city of Dana Point

AIPP offering within Prado Square to enhance aesthetic and the environment via a multisensory experience of music, art, and community engagement.



Activated by art, music and education, Prado Square's community art halls and openair stage, provide Orange County's first outdoor gallery experience. Accessible for all and powered by our community reflections on Dana Point heritage and locally inspired themes, including the following:

- Lantern and the lantern district
- Coastal and eco preservation in curated arts celebrating seafaring traditions and whale heritage site designation.
- Surf heritage
- Artistic expression via year-round rotating art gallery halls

Dynamic and multi located arts activation for the square will allow for easter eggs of art moments to attract, captivate, and capture foot traffic to Prado Square and the heart of Dana Point.



b) That the work is an enhancement to the site, surrounding neighborhood, and the City as a whole.

ACTION: Response as follows

Prado Square AIPP offering will provide energy via sights and sounds to the existing areas by locating arts offerings throughout the project year-round. It is proven that arts and culture enrich community pride by creating memorable moments that encourage placemaking and attract foot traffic to commercial districts. Our 3-point program and offering is as follows:



Rotating Art Halls – will engage local and visiting artists to be featured in one of the 3 open-aire gallery halls. These halls serve as arteries of connection that allow penetration and connection for pedestrians and guests from PCH to Del Prado through the lens of art.

Prado Square Public Square – Prado Square will be made available to organizations to host events such as RE-DO market and activate Amber Lantern with food, music, popup markets, and exposure to cultural events like the Chamber Car show as an example. This will also be home to art demonstrations as well as live music.

Lantern Mural – Serving as a visual beacon, welcoming locals and visitors alike, the lantern Mural, located on the wall overlooking Del Prado and the post office, will be a visual point arrival to our Lantern District and Prado Square cultural arts center.

This 3-point offering provides a shared benefit to all businesses alive by attracting guests to stop, look, listen, and stay awhile-- enjoying all the arts offerings and new visitors in Dana Point.


- 4. Address how each program component meets the Municipal Code definition of "public art". Potential issues may be public access to the rotating art and whether Music Preserves meets the definition.
 - a. "Public art" shall include, but not be limited to, sculpture, paintings, graphic arts, mosaics, photographs, fountains, decorative arts, film and video, and preservation of features or resources of historical, archaeological or paleontological significance, located in or on a site open and accessible to the public. Public art may be either representational or non-representational (i.e., abstract).

ACTION: Response as follows

Rotating Art Halls – will comply with the code option of providing rotating arts by artists who will meet the options of: paintings, graphic arts, mosaics, and or photographs at any of the three gallery hall locations.

Accessibility: These halls are located within public throughways and walkways on the site. They are lit and wide enough to comply with accessibility requirements.

Prado Square Public Square – will comply with the code option of providing events hosted by community organizations and also providing arts entertainment via music.



Not limited to Music preserves and open to other local musicians. This option of music is encouraged as cited here:

Per 9.05.240 "Art in Public Places" Program, Item C General Requirements Number 3 – Media, it is specified that: "(3) Media: The media used in the public art component of a new development project may include any of the features or element described in subsection (b)(5) above. The media employed should be appropriate to the artwork and the immediate physical surroundings. <u>The media chosen should also incorporate non-visual elements</u> (i.e., texture, <u>sound</u>, etc.) <u>wherever possible for the benefit of the visually impaired.</u>"

Accessibility: The square located on Amber Lantern and in public throughways and walkways on the site. The site is lit and wide enough to comply with accessibility requirements.


Lantern Mural – will comply with the code option of providing the options of: paintings, by world renowned artist drew merit. Please note this is Art and not graphic design. Artistic expression of the lantern as shown in the presentation is not subject to non-artist direction as it is fine art not graphic design or design by committee.

Accessibility: This wall is located within the City of Dana Point public realm and public sidewalks allow for visibility of vehicular and pedestrian traffic via Prado.

- 5. Narrative explaining each art program, specially include:
 - a. Rotating Art how will the program be implemented and managed? How will artists & content be selected? How often will the art rotate? What is the duration of the program? Since the halls are not readily visible from the public area, how is the public made aware of the art? Justifies the funds spent on the program.

ACTION: Response as follows:


The halls are in fact accessible as they are in publicly accessible walkways that allow for penetration of site and experience of Prado Square from PCH to Del Prado. Note these halls are open on either end and the benefit of a roof allows for comfort and lingering to take place and for halls to host art that transcends traditional mural mediums and waterproofing. For example, an artist could theoretically use textiles or other dimensional medium so long as it stays behind protective barrier of 2 inches. These are true open-aire galleries of fine art.




Art will be managed for the first two years by Bryan Snyder - a Southern Californian arts curator whose background credentials and community impact is demonstrated in his bio in supplemental deck and in the video also within deck.

The art will rotate via the schedule noted below: Please note that the infrastructure and art program will ensure that there is never more than a single day or less without art installed at each of the three sites. We will keep art in place on wall mounts while the MDO panels of new art are being delivered to site for replacement of existing art piece.

SCHEDULE:





- 1. Installation of Del Prado Lantern Mural on façade J2 of Prado West overlooking USPS parking lot (Slide 4) and installation of the Augmented Reality function of the mural to be accessed via phone/tablet and QR code.
- 2. Installation of gallery wall mounts (8'x12'), standouts, protective covers, and plaques (slide 8+9).
- 3. Inaugural installation of "Halls of Public Expression" (HOPE): Total of 3 murals to be painted and installed in hallway gallery mounting system.
- 4. First mural rotation for HOPE: 2 murals to be replaced with new murals. Artwork being replaced to be auctioned off with proceeds going towards the continuation of the HOPE program.
- 5. Second mural rotation for HOPE: 2 murals to be replaced with new murals. Artwork being replaced to be auctioned off with proceeds going towards the continuation of the HOPE program.
- 6. Third mural rotation for HOPE: 2 murals to be replaced with new murals. Artwork being replaced to be auctioned off with proceeds going towards the continuation of the HOPE program.
- 7. Musical performance to be held in Prado Square. Raintree intends to partner with the Music Preserves Foundation to host a small-stage performance with ancillary interview and educational opportunities.
- 8. HOPE Program to continue using regenerative funds from previous artworks sales. Number of mural rotations and length of program dependent on proceeds from artwork sales.
- b. Mural describe "augmented reality". How will the mural be maintained? What is the life of the mural? Explain the expenses for the mural.

ACTION: Response as follows

The Lantern mural has been a process of interviewing and securing a world renowned artist who had experience honoring oceanographic heritage and demonstrating world class art. Drew Merritt, is indeed a world renowned artist who has been a part of conservation efforts via <u>Pangeaseed</u>, which inspires ocean stewardship through science education and artivism.

AR equates to Augmented Reality and offers a way for a viewer to engage with a work of art using phone technology to see another dimension through a phone screen. This technology is new and will be accessible via a QR code nested on the plaque located on the building below the mural.

The life of the mural is 15 years + barring natural disaster or change of building.



The expenses for this effort are attributed to curation, installation, protection of the artwork through protective barrier. Note that spec sheets for paint and protective barrier are also provided in the accompanying deck.

c. Music Preserves – what is the program? how will the funds be used? ACTION: Response as follows

Music preserves is one option for music. Our goal is to ensure a number of artists versus one single cost inhibitive source of music. Music Preserves is a local group that has familiarity with the City, and we are committed to providing an offering in the public square that allows for music to be an element within the fabric of the three-part art and culture experience of sight, sound, and education through exposure to all kinds of artists.

Note that music will be a part of other community hosts who use the site for eventing and pop-up experiences. Example: Re-do market.

6. Condition of approval. Since the rotating art and music program are ongoing, a condition of approval will be created to discuss what happens if the program is not implemented.

ACTION: Response as follows

This activated square and repositioning of Prado West as **Prado Square** is a long-term, permanent commitment to engage and enrich arts and culture in our community of Dana Point. There is no wavering from our efforts as they will in fact support businesses, economic vitality via community spirit by bringing foot traffic and buzz factor to our downtown.

Raintree is committing to a two-year rotating art program as described herein in accordance with our proposed AIPP fee use. Raintree will use any proceeds from the sale of these rotating art pieces to continue to the program for an undetermined amount of time. Further, Raintree will provide the City with confirmation of AIPP fee use including payments made in connection with the AIPP proposed program to ensure that our funding requirement is met. Should any funds remain after the two-year operating period and Raintree elect to discontinue the program, any remaining AIPP fee balance will be returned to the City.
