PUBLIC COMMENTS

Wayne Yost (Dana Point / VFW Post 9934) commended Mayor Federico for his strong leadership over the past year.

Dana Yarger (Dana Point) wished the community happy holidays and shared that the Elephant Parade exhibition has been extended. He provided a handout to Council regarding the mastodon discovered in Capistrano Beach in 1929. He expressed hope that the City will continue the elephants' legacy by increasing the number of permanent installations around town.

Donna Molina (Dana Point) spoke regarding a large, loud wedding at Project Social and the issues she faced when calling the non-emergency and code enforcement lines, as well as 911, regarding her related noise complaints.

Mayor Federico directed Staff to contact Donna Molina regarding the noise incident.

Vickie McMurchie (Dana Point / Chamber of Commerce) thanked Mayor Federico for volunteering over the past year and his support of the Chamber of Commerce and community.

Principal Planner Belinda Deines provided a Staff Report.

Mayor Jamey M. Federico re-opened the Public Hearing at 6:23 p.m.

Gerald Egner (Appellant) stated that the Applicant and Architect didn't intend to resolve the issue and reminded Council of key points in his previous testimony given at the November 2, 2021 meeting. He stated that the project does not positively contribute to the neighborhood and negatively impacts his home. He questioned future projects and how Council would respond to future development.

Jeremy Culp (Homeowner) confirmed that he met again with the Appellant. He reiterated that the plans meet the needs of his family and compared them to other homes in the neighborhood. He expressed confusion as to why he was before Council and detailed the time and money he has spent on the appeal process.

Michele Casler (Capistrano Beach) stated she lives across the street from the Appellant and built an ADU above her parent's garage in 2020. She spoke about previous incidents with the Appellant opposing her project and speaking to other neighbors against it. She spoke in favor of the Applicant and his project.
