## 15. CANNABIS POLICY AND SURVEY RESULTS

City Manager Michael A. Killebrew introduced the item.

Adam Sonenshein (FM3 Research) provided a presentation with survey results and answered questions from the City Council.

Discussion ensued.

Dave McPherson (HdL Companies) provided a presentation and answered questions from the City Council.

Mayor Joseph L. Muller opened Public Comment.

Chuck Pillsbury (Dana Point) spoke against cannabis dispensaries in town.

Katie Armstrong (Capistrano Beach) encouraged the City Council to speak with other city councils that have allowed cannabis sales and spoke in opposition to them.

Toni Nelson (Capistrano Beach) spoke against cannabis dispensaries in town, stating that they do not fit with the town and that the City Council should consider public safety and the previous proposed tax measure, which failed.

Damian Collins (San Clemente, Dana Point business owner) spoke in favor of cannabis dispensaries in town, stating that they would be reputable buildings with security and community outreach would take place. He spoke of customers and how they would benefit, and stated that any dispensary would be regulated.

Marla Freeman (Dana Point) spoke against cannabis dispensaries in town and stated that delivery is available for residents.

Discussion ensued.

IT WAS MOVED BY MAYOR JOSEPH L. MULLER, SECONDED BY MAYOR PRO TEM MIKE FROST, TO DIRECT STAFF TO RESEARCH WHAT AN ORDINANCE SHOULD LOOK LIKE REGARDING CANNABIS DISPENSARIES IN TOWN.

A FRIENDLY AMENDMENT WAS MADE BY COUNCIL MEMBER JAMEY M. FEDERICO TO DIRECT STAFF TO INVESTIGATE BEST PRACTICES FOR CONTROLS, MITIGATION EFFORTS AND REGULATIONS ON CANNABIS DISPENSARIES, INCLUDING TAX MEASURES.
