#### 4. UPDATED INVESTMENT POLICY

Member Killebrew provided a staff report and informed the FRC Committee that the only change is the date.

#### 5. COASTAL ANIMAL SERVICES AUTHORITY UNFUNDED PENSION LIABILITY UPDATE

Staff Member Shelton provided a staff report.

Member Federico informed the FRC Committee that the Coastal Animal Services Authority (CASA) unfunded pension liability is only 75% funded and it will possibly need to be up to 90% funded to enter CalPERS.

Discussion ensued.

It was moved by Member Federico and seconded by Vice-Chair Frost to recommend to the City Council to authorize a set-aside from the City's General Fund of \$334,720, which is the estimated portion of the CASA unfunded pension liability that is estimated to be the responsibility of the City of Dana Point.

# 6. SECTION 115 TRUST PENSION LIABILITY UPDATE

Staff Member Shelton provided a staff report and that Staff is recommending the PARS Pension Rate Stabilization Program (PRSP) for Section 115 Pension Trust services, and Vanguard to provide investment management services.

Discussion ensued.

It was moved by Member Killebrew and seconded by Vice-Chair Frost to recommend to the City Council to authorize a contract with PARS for Section 115 Pension Trust services and Vanguard to provide investment management services; and that Staff work on options for investments to provide at the April 26, 2022 meeting.

#### STAFF REPORTS

Staff Member Shelton informed the FRC Committee about the upcoming mid-year review going to the City Council on March 1, 2022 and the Long Term Financial plan discussion on March 15, 2022. She also informed the FRC Committee that if Council approves the updated Strategic Plan, Staff will bring possible recommendations for resourcing discussion at the April 26, 2022 meeting. Staff is finalizing their decision on the new budgeting software and should have a contract to City Council on March 1, 2022.

Member Federico thanked Member Mitchell for serving two consecutive terms as Chair, and thanked Chair Amezcua for being the new Chair and he also thanked Staff Member Shelton for her professional reports.
