## 3. UTILITY BOX ARTWORK PROGRAM UPDATE

Staff Member To provided an update on the Utility Box Artwork Program. The final box of Phase 2 of the program has been completed. The box titled "Crashing Waves" by artist, Katie Powers, is located on Pacific Coast Highway and Monarch Bay Plaza. More information about the completed utility boxes can be found on the City's website. The Call for Artists for Phase 3 of the program opened on March 21<sup>st</sup> and the deadline to submit applications is May 20<sup>th</sup>. The Arts & Culture Commission will review applications and select winners at the next meeting on June 8<sup>th</sup>.

## **NEW BUSINESS**

#### 4. WHALE OF A KID'S ART & LITERATURE CONTEST COMMUNITY CENTER DISPLAY

Staff Member To announced the winners of the Whale of a Kid's Art & Literature Contest and proposed to display the 48 art entries and 4 literature entries at the Dana Point Community Center.

Discussion ensued.

#### 6. DANA POINT ART FEST

Vice-Chair Schnell announced that the 7<sup>th</sup> Dana Point Art Fest is coming up on Sunday, June 5<sup>th</sup> from 10am-5pm on Del Prado Avenue from Violet Lantern to Amber Lantern where artists will have the opportunity to display their artwork on the street.

Discussion ensued.

#### 7. DANA POINT PLEIN AIR FESTIVAL

Commissioner Keene provided a handout and project summary of the Dana Point Plein Air Invitational, which invites 100 artists to Dana Point for a week-long celebration of outdoor painting. At the end of the week, there will an event to exhibit and auction off the artwork. There is no date for the event yet, but Commissioner Keene is proposing sometime in the summer or early fall.

Discussion ensued.

## 8. DANA DAYS: ART, MUSIC AND CULINARY EVENT

Commissioner Keene provided a handout and project summary of Dana Days, which will be a fusion of an art, music, and culinary experience, highlighting the culture of Dana Point. The event would be quarterly and have a different theme each quarter. The first theme would be "Endless Summer" highlighting surf culture in Dana Point. The second theme would be "Tis' the Season," designed to complement the holiday activities already going on in town. The proposed location would be on Del Prado and extend throughout the Lantern District, but also other locations through a "passport." Commissioner Keene has also been collaborating with the Dana Point Entertainment Arts Council, Ryan Cueva of Cueva Entertainment, and the Pop-Up Shoppes on this event.

Discussion ensued.

#### 9. DOHENY VILLAGE PUBLIC ART SCULPTURE

Staff Member Sinacori presented a public art sculpture that Jerry Lanksy, the welder in Doheny Village, is designing from reclaimed materials to be displayed at the end of the cul-de-sac on Las Vegas Avenue. Jerry's vision is to create a piece of industrial art to beautify the area and has the support of the Doheny Village Beautification Committee.

Discussion ensued.

## 2. LANTERN BAY PARK STAIRS UPDATE

Staff Member Sinacori provided an update on the Lantern Bay Park Stairs project. He provided a tile sample to the Commissioners and discussed ways to protect the art as well as costs for the project, including railing and landscaping.

#### **10. ARTIST IN RESIDENCE**

Commissioner Wallin provided flyers to the Commissioners and announced that the Dana Point Entertainment Arts Council selected Chris Justice, a local Dana Point high school graduate, will have a residence in Dana Point for 3-4 months in a space that Raintree Partners has provided for the program. There will be an open reception on Saturday, April 23<sup>rd</sup> from 5pm-8pm and asks Commissioners if they have any recommendations for artists to rotate to continue the residency.

Discussion ensued.

## ARTS AND CULTURE COMMISSONER REPORTS

Commissioner Keene added that last time Todd mentioned about having an interactive art walk along the stairs and the original proposal was for Chris Justice to do paintings with a QR code to scan and learn about Dana Point's history. However, after speaking with Todd and Chris, the idea is to now expand it to take place all over Dana Point and include different artists as well.

Commissioner Wallin shared that the Dana Point Entertainment Arts Council is now fully funded and is receiving requests from donors. Commissioner Wallin also announced that he will be resigning from the Commission effective immediately and focus his time on the Dana Point Entertainment Arts Council. He thanked the Commissioners for the art education during his time on the Commission and will support art activities through the non-profit.

Vice-Chair Schnell stated that Arts Orange County put in their newsletter that public art in Orange County surpasses 1,000 works, which includes the new Doheny Village mural. Vice-Chair Schnell also wanted to highlight the City's Lookout Magazine and how great it is having Joyce Hoffman on the cover with an article about her. She also mentioned that the Dana Point Symphony's upcoming concert, Summer Pops, will be on Saturday, June 4, 2022 at 7:00pm at the Kaleidoscope in Mission Viejo.

Chair Jenkins shared that the Lord of the Strings who plays acoustic guitars have an upcoming event at Mission Viejo City Hall. Their first event is on April 30<sup>th</sup>.
