13. LONG-TERM FINANCIAL PLAN / BUDGET PRIORITIES — UNFUNDED CAPITAL IMPROVEMENT AND FACILITIES PROJECTS

City Manager Michael A. Killebrew introduced the item.

Dana Yarger (Dana Point) thanked staff and Council for their management of the budget and provided a letter with suggestions for the use of surplus funds.

Mike Yousef (Dana Point, PAL) asked for a budget line item for undergrounding of utilities, as well as allocating staff time to grant writing for additional funding.

Jill Richardson (Dana Point) spoke regarding the budget surplus and indicated the funds should be used to address election inconsistencies and the lack of a mayor at-large.

Len Gardner (Dana Point, PAL) spoke of recent fires and the dangers of overhead powerlines.

Susan Berkman (Dana Point, PAL) suggested allocating funds to utility undergrounding.

Discussion ensued.

City Attorney Patrick Munoz also reported that the California Coastal Commission will be conducting a public hearing on the appeal of the Short-Term Rental Coastal Development Permit on November 16th and provided details on the upcoming process and procedures.
