1. RECOGNITION OF PLEIN AIR ARTIST

3. LANTERN BAY PARK STAIRS UPDATE

Staff Member Reenders provided an update on the Lantern Bay Park Stairs project. The railing is currently being fabricated, which will take 2-3 weeks and Staff is working with the landscape architect and Greek Concrete on the tile work that will go on the stairs to protect the mosaic tiles.

Commissioner Keene explained that she worked with Chair Jenkins on the Ad Hoc Committee to work with the Dana Point Historical Society to choose photos that were relevant to the location of the utility box on Golden Lantern and Dana Point Harbor Drive. The photos chosen were "The Last Day of Surfing," "The Hide Drogher Statue," "Scenic Inn," and "Artist's Rendition of Woodruff's 1925 Vision of Dana Point," which were all historical points of value in the Harbor's history.

6. DANA POINT SISTER CITIES UPDATE

Bob Zasa, President of Dana Point Sister Cities, provided an update on their efforts including potential sister cities with Sorrento, Italy and Thessaloniki, Greece, a pending friendship agreement with the City of Laguna Niguel, as well as sponsoring an event during the Maritime Festival, cultural trip to New York City, and a Greek cultural event in Laguna Niguel with all proceeds donated to local non-profit organizations. A lot more events are being planned for 2023 with an invitation from Sorrento, Italy for an artist expedition as the first friendship event.

7. LOCAL ARTS AND CULTURE RELATED NON-PROFIT ORGANIZATIONS

Commissioner Smith Hatch provided an update on the database for local arts and culture related non-profit organizations, which is close to being completed. The next steps would be to host a collaborative meeting in early 2023 with the goal to share calendars, resources, ideas, and encourage them to engage with each other on events.

Commissioner Banks explained that the holiday market and festival's name changed from Santa Crawl to Sleigh The Holidays. There will be music, vendors, wristbands with a VIP section, children's area, food and beverages. Commissioner Keene added that there has been a lot of community involvement with this event and hopes everyone will join them that day to support local businesses and create memories with family and friends.

The Sleigh the Holidays Market and Festival will take place on December 4th from 11am – 6pm on Del Prado Avenue.

ARTS AND CULTURE COMMISSONER REPORTS

Vice-Chair Schnell added that Mia Tavonatti has art in space. She also mentioned that Stand Up To Trash is having an event where you can create art pieces in the morning at Baby Beach.

Commissioner Keene reported that the Laguna Cliffs Marriott has begun hosting their art gallery pop-up in their lobby, which includes different local artists, including herself, coming to showcase their artwork. It will be hosted every Saturday in November from 11am – 7pm.

Commissioner Banks commended on how nice the Redo Vintage & Maker's Market event was.

Chair Jenkins shared that the Lord of the Strings upcoming event is the Richard Smith Solo Show on November 19, 2022 in Mission Viejo. In addition, on November 10, 2022 from 7pm – 9pm, there will be a Living Legend of Jazz event featuring Elena Gilliam at the Casino San Clemente.
