**Zone Text Amendment ZTA23-0001 – Accessory Dwelling Units:** A request to amend Dana Point Zoning Code Section 9.07.210 affecting Accessory Dwelling Units and Junior Accessory Dwelling Units regulations. On May 15, 2023, the Planning Commission is scheduled to review the proposed amendment and make a recommendation. Any action or proceeding to attack, review, set aside, or void any decision of the Dana Point City Council is controlled by Section 2.50.010 and Section 2.50.020 of the Dana Point Municipal Code. In any such action or proceeding seeking judicial review of, which attacks or seeks to set aside, or void any decision of the Dana Point City Council, shall be limited to those issues raised at the hearing as provided in Chapter 2.50 of the Dana Point Municipal Code.
