#### 10. SHORT-TERM RENTAL PERMIT DATA

Council Member Villar provided a report.

Toni Nelson (Capistrano Beach) spoke regarding the number of short-term rentals inside the Coastal Zone and urged the City Council to amend the Coastal Development Permit.

Discussion ensued.

IT WAS MOVED BY COUNCIL MEMBER VILLAR TO AMEND THE COASTAL DEVELOPMENT PERMIT TO ELIMINATE THE LANGUAGE OF 115 SHORT-TERM RENTALS INSIDE THE COASTAL ZONE AND OUTSIDE THE COASTAL ZONE, AND AMEND THE LANGUAGE TO STATE 1.5 PERCENT OF AVAILABLE, POSSIBLE SHORT-TERM RENTAL UNITS INSIDE THE COASTAL ZONE AND 1.5 PERCENT OUTSIDE THE COASTAL ZONE.

THE MOTION FAILED DUE TO LACK OF A SECOND.

## 11. DPMC UPDATE TITLE 13.04 PARKS AND RECREATIONAL FACILITIES - DAYLIGHTING

Assistant City Manager Kelly Reenders provided a staff report.

IT WAS MOVED BY MAYOR PRO TEM FEDERICO, SECONDED BY COUNCIL MEMBER PAGANO, THAT THE CITY COUNCIL AUTHORIZE THE CITY MANAGER TO EXECUTE THE LAW ENFORCEMENT SERVICES AGREEMENT WITH THE COUNTY OF ORANGE FOR LAW ENFORCEMENT SERVICES FOR FISCAL YEAR 2023-24 (FY24); AND, AUTHORIZE THE CITY MANAGER TO EXECUTE AMENDMENTS TO THE AGREEMENT IN AN AMOUNT NOT TO EXCEED THE RELATED COUNCIL APPROVED BUDGET.
