NOTICE IS HEREBY GIVEN THAT a public hearing will be held by the Planning Commission of the City of Dana Point to consider the following:

**Site Development Permit SDP24-0008 located at 34101 Calle La Primavera:** A request to allow the construction of a 989 square foot, two-bedroom, detached Accessory Dwelling Unit on a lot containing an existing nonconforming duplex dwelling in the Residential Single Family 4 (RSF 4) Zoning District. Lots with existing developments that are nonconforming as to the minimum parking requirements, must obtain a Site Development Permit pursuant to Dana Point Zoning Code Section 9.07.210(f)(1)(C) prior to constructing the detached ADU. In accordance with Dana Point Zoning Code Section 9.07.210(f)(4)(A), in single-family residential zoning districts where ADUs are permitted, an applicant shall be allowed to construct one (1) detached ADU per lot.

All persons either favoring or opposing the subject project are invited to present their views to the Commission at this hearing.


