APPEAL OF THE PLANNING COMMISSION DECISION TO APPROVE COASTAL DEVELOPMENT PERMIT CDP24-0010 AND SITE DEVELOPMENT PERMIT SDP24-0017 FOR DANA POINT STORAGE: On June 24, 2024, the Planning Commission approved the request to allow the demolition of existing improvements and the construction of a two (2), detached, three (3) story, indoor self-storage buildings with required parking, hardscaping and landscaping on each lot. The project consists of non-residential development over 2,000 square feet, a floor to area ratio increase request and a reduction of loading spaces and is located within the Village Commercial/Industrial (V-C/I) zoning district of Doheny Village, as well as the City's Floodplain and Coastal Overlay Districts, thereby requiring approval of a CDP and SDP. Since the Planning Commission's review, the project has been modified to comply with regulations related to floor area ratio. On July 3, 2024, Capistrano/Fortune Partners, LP filed an appeal of the Planning Commission's decision.

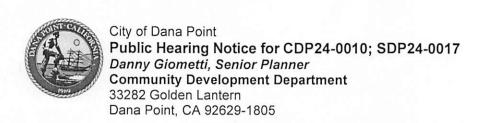

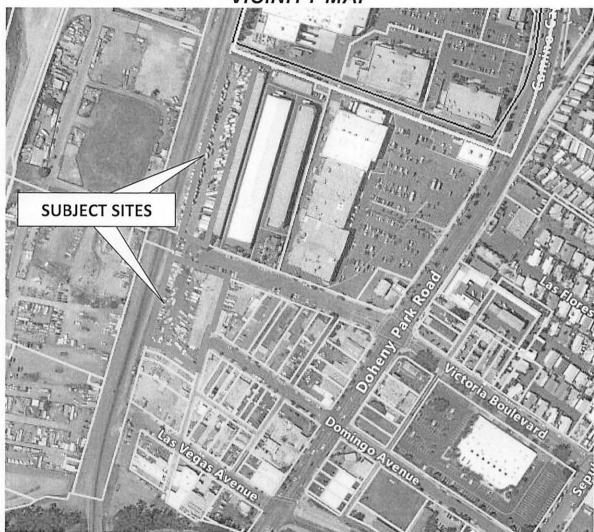
