Site Development Permit SDP23-0028 and Administrative Modification of Standards AMS24-0008 located at 33822 Silver Lantern Street: A request to allow an addition totaling 1,522 square feet to an existing nonconforming three-story, single-family dwelling, the construction of a 284 square foot roof deck, and a retaining wall greater than 30 inches within the front yard setback area. Site Development Permits are required for the project pursuant to the following Dana Point Zoning Code Sections:

- Section 9.05.110(a)(4): three-story residential structures in a hillside condition;
- Section 9.63.030(a): ten (10) percent or greater expansion of gross floor area of a nonconforming structure;
- Section 9.05.230 roof decks in any zoning district; and
- Section 9.05.120(c) and (d)(2) retaining walls greater than 30 inches in height in the front yard setback.

An Administrative Modification of Standards is requested to allow for architectural projections to exceed more than 2'6" into the required setback areas, pursuant to Dana Point Zoning Code Section 9.61.090(b)(1).
