**NOTICE IS HEREBY GIVEN** that on August 19, 2008, the City Council of the City of Dana Point will conduct a public hearing to consider the following:

**RE-APPROPRIATION OF CITIZENS OPTION FOR PUBLIC SAFETY  
(COPS) PROGRAM FUNDS FROM FY 2007/2008 – (AB 1913)**

Said public hearing will be held at 6:00 p.m. (or as soon thereafter as possible) in the Dana Point City Council Chamber, 33282 Golden Lantern, Dana Point.

The City Council will hold a public hearing to address intended uses of the 2008-2009 Citizens' Option for Public Safety Grant Funds. The City will receive up to \$100,000 to enhance police services. Police Services believes the funds should be used to offset costs necessary to fund a School Resource Officer and for additional patrols, including bicycle patrols, in our city parks to stem vandalism and graffiti.

Those desiring to be heard in favor of or in opposition to this item will be given an opportunity to do so during such hearing or by writing to the City Council at 33282 Street of the Golden Lantern, Suite 203, Dana Point, California 92629, Attention: City Clerk. Please reference hearing title and date of hearing in any correspondence. For further information, you may contact the City Clerk at (949) 248-3505.

Any petition for judicial review of a decision of the Dana Point City Council, is controlled by the statute of limitations provisions set forth in Sections 2.50.010 and 2.50.020 of the Dana Point Municipal Code and Sections 1094.5 and 1094.6 of the California Code of Civil Procedure. Any action or proceeding to attack, review, set aside, or void any decision of the Dana Point City Council is controlled by Section 2.50.010 and Section 2.50.020 of the Dana Point Municipal Code. In any such action or proceeding seeking judicial review which attacks or seeks to set aside, or void any decision of the Dana Point City Council shall be limited to those issues raised at the hearing as provided in Chapter 2.50 of the Dana Point Municipal Code. Copies of the procedures for the conduct of City Council public hearings are available from the City Clerk.
