<u>Minor Conditional Use Permit CUP24-0005(M) located at 24471 Del Prado Avenue,</u> <u>Suite C</u>: A request to establish a Recreational Use (Sweat House) located within an existing vacant suite on the ground floor of an existing mixed-use building located within the Town Center Mixed Use (TC-MU) Zoning District. Pursuant to the Land Use Matrix within the Dana Point Town Center Plan, a Recreational Use is permitted, subject to review and approval of a Minor Conditional Use Permit.
