Minor Conditional Use Permit CUP24-0007(M) at 34137 Golden Lantern: A request to establish an Alcoholic Beverage Outlet (Wine Experience) Type 20 (Off-Sale Beer and Wine) and 42 (On-Sale Beer and Wine – Public Premises) Alcoholic Beverage Control (ABC) licenses to allow the sale of alcoholic beverages for consumption on and off the premises located within the Town Center Mixed Use Zoning District.
